

17 On October 7, 2019, this Court issued an order denying Movant's petition for
18 a writ of certiorari in the above-entitled case, entering said order on October 12,
19 2019, filed on October 15, 2019, with regards to United States Court of Appeals for
20 the Ninth Circuit Case Number: 19-15446, ID 11463000, filed on August 18, 2019,
21 at Docket Entry 7.

26 moved to rehear said petition on the grounds that:

1 (1) Movant did provide the required and requested Circuit Court Splits
2 necessary regarding the treatment of [subsequent] "superceding" or "superseding"
3 Indictments, as seen at Appendix G, and throughout said Cert Petition.

6 (2) If this Court does not rehear said Petition and vacate the underlying case,
7 Movant will not go quietly into the night (see "Do not go gentle into that good
8 night," a poem, by Dylan Thomas). Instead, this Court's unexplained failure to
9 uphold the Bill of Rights to the United States Constitution, not the least of which
10 included the Indictment of a Grand Jury guarantee, will become widely known. In
11 this case, this Supreme Court did not correct and reverse the District Court's error
12 when striking-deleting-redacting a substantive charge from both Counts of the
13 Grand Jury's Indictment, seen at Appendix C (here, [intent to intimidate]) without
14 first reconvening a Grand Jury to approve of the trial-Judge Court-issued Trial Jury
15 distributed Subsequent Indictment seen at Appendix D, filed on the last day of trial,
16 among many other constitutional violations that implicated plain reversible errors.
