## STATEMENT OF THE CASE

It has been repeated events that have cause me to have complex post trauma stress disorder. As I become older and gain more information, I have realized that Christianity strip you from your true spirituality. I read into a few articles speaking about a spiritual war, so beside all the abuse and death I had to witness, I have thought back to everything that happen in my life. These war crimes that has been placed on my life from this western culture, has striping my natural rights. I have the right to not have my life based on a program that rob you from critical thinking and leaving you surrounding, while stealing your imagination, leaving you weak and defenseless, living in fear. While you have government official placing threats upon in life so you can bow down to its authority.

Created different types of disability by psychological manipulating the environment. Leading us with false teaching and stripe our culture, while been forced to take on this western culture, not caring how family genetics would affect us. Due to the abuse I am an alcoholic. My family are natives and we have been lied to for years, stating that we are African American, to deal with the prejudice, and except that we have been keep from our proper resource. We're been abused and manipulated about our heritage. Tore our family apart, force to inherent a poor lifestyle. My first jobs they wouldn't hire me on permit because I was pregnant, and they don't favor color. So you get abuse through life and they force you to work 12 hours and 7 days a week, or if not that. They offer you a job working 12 hours on a rotating shift like your body can adopt to that. Like this system didn't create me to be a struggling single mother, like I don't have a home to attend too. At what point do I suppose to rest, to heal, to keep myself from having cognitive distortion, but the thing is my mind is not lieing my reality it really set up to make me think I'm insane but the whole but most of the world believe a dead man coming

back to save them.

When you try to remove yourself for the contract, they found a way to try to through you back into the contract to injure you with there drugs. Saying I delusional but I'm not the one praying to and invisible man. Say you have a mentally illness and through you in the mentally hospital, if they see you as a threat, they abuse their power, and use news to display false behavior, so the people will be entertained with media, copying media behaviors so there corruption can stay hidden, human trafficking, and robbery, no money keep you a slave to the system. So, finding a home is out the question when they are asking for you to make three times your rent and only offering low paying jobs.

Keeping community full of half-educated people, with no self understanding, people think its okay to live that way. Multiple disability, countless of mental illness using media, school system, and religious program to help keep us with low consciousness, while keeping the violence and crime going in low class community for a large profit. These polices are to strict to the point where health is no concern, depriving me from life and liberty, by been harassed, mentally, physically, financially, and emotionally abuse. When you are able to think for yourself, they work together to try to say you delusional and insane because you see the attack imposed on your life, I have damage nerves and suffer from chronic anxiety disorder, and depression. Had to walk through life and realize that my family was mistreated and was forced to accept, government officials abuse.

My mother with an 8th grade education thinks it fine to live off government assistant. When you try to step away from your past and you are secretly been gang stalked, by government officials. They a trying to force me to become ill. Now I see the story behind why my great grandmother couldn't raise my grandmother, repeated pattern and practice. My family was left with nothing and natives was force in school system didn't work for them.

\*At age the 16, I was subpoena to a murder trial. I was served without my mother consent, I witnessed them let a few murders walk free. A few months after the murder trail someone shot at me and was about 12 inches away from my face.

\*One day as a little girl I witnessed my Mom being abused. Then they let this man back into the home, the same night they removed my gun. I had pulled my gun out on him, I was 17 years old; that same morning he went and bought his self a gun, which put my life back at risk.

\*Then I had to go to court for my first child father, due to child support, I thought I was going to get some support, but the state. said, "He didn't have to support his child and that he is drawing for disability so he don't receive enough to support her and said since I been doing it alone this long I minds will continue." So, I figure Social Security supporting him maybe she can get a check to assistant since the state said, "he didn't have to provide for her, "I was turned down because my child's father didn't work. I couldn't draw a check for her, but I see this system will support a man that lived his life instead of helping young babies that still have a future ahead of them. That young man is in and out of jail and prison and he is disable. But would leave me struggling to raise her alone.

\*My grand mother supposedly had cancer. She went through the process and I witness, having her go weekly to chemo treatment and at the end of the chemo treatment, she was giving a due date (02/14/2009). When an illiterate man forge, her name to sign some papers, she was then sent to hospice to end the process. They kept her drugged up, getting rob by this system and her husband help with her killing process but before that last operation, she had others. Operation

after operation then bankrupt and then Spartanburg hospice. You can't pay for health.

\* I called the Sheriff Department because I was scared, the Sheriff Department would not send anyone out. They stated, "They would send an ambulance out because I was crazy." I was scared, because I gets videos about targeted Individual, and gang stalking. Tried to file a complaint at the courthouse and they call three officers and surround me to say, "that they can't help me." So that flowing Monday, because they was shooting electromagnetic impulses in my head and had me up for 3 days, I called the non-emergency line to see if someone would come out, they send the ambulance, fire truck and a police out, and forced me to the mental hospital.

\* Was up late drawing and I decided to go to bed at 1:00 a.m. I hear some guy's outside the apartment building, and they were robbing some other guys, so they take off running... I get in the bed and says to myself, "that's not my business," go to sleep wake up scared because I hear gun shots at 4:00 in the morning my child father was shot up while in the house sleep right across from me.

\* When I first moved in that apartment, I had a thought of putting my little girl in her room for the first time and that next morning I woke up to bullet holes going through my little girl wall.

\* Took this online class at Kaplan University and I remember Financial Aid said they was going to see if I can get a loan through Bank of American and I never heard any thing from them. After I withdraw from the school, I receive a letter stating that they took out two loans with Citi Bank. So, I call the school and they stated that they returned the loan back. Great lake stated that I owe the full amount back so in 2018, U.S. Department of Education take my tax return. But left 100

left on the accounts to interfere with my credit after they remove 6,000 and so dollar and left me with like 1100 in my bank account. I'm trying to figure out why did they leave 100 dollars on my bounce. Maybe to keep me in debt to affect my credit score some more. My credit score is low, and I can't apply for nothing. And I do remember contacting Lindsey Graham before they took it and he told me to get a lawyer. Graham introduced the Terrorist Surveillance Act

\* Department of social service workers has tried to impose themselves in my life about three times and that can truly destroy one's reputations trying to label me as an unfit mother I thought natives has self-determination.

\*I have received a few speeding tickets and the fee was over 500 hundred dollars. not only are you being rob for your money, but its left on your record, and your insurance is high.

\*My car had broken down on the side of the road one day, I was wait on my check to get it towed. They removed my car and said, "I had to pay 1500 dollars to get it back.

\*One day my brother stole my car while I was sleep and he had a warrant out for his arrest and I didn't know, the police caught him a few house away from my home, they had my car towed all the way to a Enoree, South Carolina had to pay 250 to get the car.

\* They control your appliance in your home running your bills up while adding unknown charger and increasing the rate forcing you out of home.

\*Goes to court and the Judge James Donald Willingham II didn't look at any of my evidence didn't follow due process at all. Court case was

fraudulent that's when I witness human trafficking, and money laundering within the community, staying in that home has cost me a great deal on my lights and water bills and the home had issue after issue. In trail the officer took my folder out my hand to distract me, in trail and when I was leaving out, he came up to me and threatening me.

\*Then I supposedly had a court date on my birthday 02/05/2018 and it was handled unprofessionally. My last child father kidnapped me and beat me, I went to court on the 02/07/2018 for that case because they called me to come in, the case didn't happen that day. The solicitor Tatyana Stepanoena told me, "she will let me know when to come back," missed work for that case. My case with my child father, Judge Hayes J Mark II, gave him a fine, and stated, "He didn't see any reasons to take any further actions." He made an unfair decision as if my life didn't matter. This boy beat me, had my face swollen and made physical markings on my body.

\* I ask the doctor where bacterial and yeast infections come from doctor said she not sure. After I have my baby about a few months later I receive a letter in the first-class mail telling me to come in for some testing, because of an abnormal pap test. I went in and the lady cut the inside of me, I called later that week for the results. I was told they didn't know and that I needed to come in for more tests. I didn't have a problem until this woman decided to go cut. I found some natural herbs to heal my pain. Instead of her cutting me she could have just told me to watch my PH level.

\* when you realize that the school system you try to sign up for and opportunity, they grant the opportunity only to a select few. The district is committing mail fraud and making threats to have you come to court for a fine. They run tell DSS on me cause my son was sleepy one day, that is no reason to go run to tell a public official to try to have my

child removed.

\*As a child I had hit my head hard a few times and one time a man followed my family and I from the park that same day. Thought back on my life and realize that was the first sign of gang stalking. I hit my head so hard I couldn't see for half that day. I have come to see this control system and I didn't sign up for this military training.

I do know I was forced to see way too much, and this is not the experience I was hoping for. Just wanted to be an artist but now I just investigate crimes. I had thought about this man one day and I made a post on Facebook, about how the people are programmed and designed to kill themselves. A day later I woke up the man I thought about killed himself. They have killed and injured a lot of men that I have had a relationship with. One day on Facebook they have been on my post telling me to re-post something else cause it was similar to my last post. And one time I made a post about how they have turned the guys sensitive, so we have domestic violence now a few weeks later my family was almost beat to death. Someone has violated my privacy and freedom of speech.

CIA mind control program (MK ULTRA) has walked me through this whole system, to see this western culture. I think I was abuse so I could turn to some type of substance abuse, or to commit suicide or to react out on how I was abused. Study shows that natives turn to alcohol or commit suicide. Someone has been shooting electromagnetic impulses in my head and giving me depression and wake me up every morning at the same times about 3 to 5 to keep me tired, to help drain my energy. They have been in my thoughts and helps me, from been torture and abuse has taken a toll on my life and I didn't sign up to be abuse for this Age of Aquarius. (Luke Chapter 22:7)

Beside this spiritual war I am not a Christian, and they have imposed this Christianity in my life, and someone set my life up to

witness this abuse. Abuse me so much for me to see how government cause some much problems in my life, to see how religion, has left the people with no consciousness, everyone think I'm crazy because I have a different point of view from them and they can't understand me because they was left and not allowed to do any critical thinking for themselves. I see the control system and I didn't sign up for this military training. This has been a war on my nerves and my nerves are damage, I am 30 years old and have been deprived from life and I have a horrible relationship with my family due to their understanding. This system has imposed attacks in my life, and no one seem to understand it.

First and fifth and fourteenth Amendment has been violated. As a natural person, I shouldn't have to come out the womb to be tortured and abuse just to keep this religion going... I can't be great if I'm been forced to surrender to a culture and belief that's designed to use force and deadly force on indigenous people. Multiple threats have been places on my life, and causing me to remain in poverty, and now its like they all trying to classify me as insane. I see the respect for my liberty and its not within the interest of this infrastructure. Official has abused their power and has not followed any rules nor laws. I have been trying to reach out for some support and no one in executive branch would help.

Now I'm trying to figure out, how such force can be placed upon my life that deprives me from life. They have cause me to isolation myself, I have talent and skill of doing anything, how came I'm not allow to create the American dream for myself, because I'm native and the force on our lives never end just created in different ways so we can't notice the gang stalking that government official are imposing a silent war crime. Now I have this wrongful judgment on my record it is going to be very hard for me to get a home for me and my babies, now I am homeless.
