writ of certiorari in forma pauperis.


To show that petitioner was represented by appointed counsel in the

DECLARATION OF JONATHAN GROSSMAN

I am an attorney licensed to practice in California. I am a member of the bar of this Court. I am the attorney of record for petitioner Tham Bui.

The facts stated in this declaration are within my personal and firsthand knowledge. If called as a witness in this action, I could and would testify competently under oath to the following facts.

Petitioner filed a notice of appeal which indicated he was indigent. A copy of this notice is attached as Exhibit A. The Sixth District Appellate Program, by whom I am employed as a staff attorney, is contracted with the court to administer the appointed counsel program for indigent criminal defendants on appeal. The Sixth District Appellate Program recommended an attorney to handle the appeal. The Recommendation in this case showing that I was the attorney appointed to represent petitioner is appended to this declaration as Exhibit B. I have remained petitioner's counsel of record to this time.
