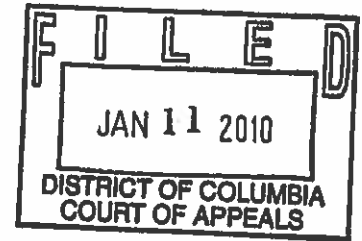


On consideration of this court's order of December 22, 2009, wherein this court appointed Charles D. Murdter, Esquire in appeal no. 09-CF-1482,
