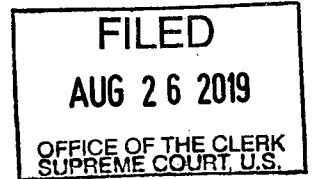

"Since my arrest & detention on Oct. 26, 2014, my main source of income have come in the form of "Gifts" from family & friends. As of February & April of this year, 2019, the primary contributors to my resource while incarcerated, both died, respectively in months. My wife of 15 years, has never worked, or held a job past the probation period of obtaining permanent employment, & has never contributed to my welfare during my incarceration, nor when I was free. Due to her own present state of dire circumstances, I have no reason to believe that my indigent status will in the present, nor future, change."
