**MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***


Pursuant to Rule 39 of the Rules of this Court, the petitioner, David Tkhilaishvili, moves to file the attached Petition for Writ of Certiorari to the United States Court of Appeals for the First Circuit without prepayment of costs and to proceed *in forma pauperis*.

The petitioner was represented at trial in the United States District Court for the District of Massachusetts (No. 16-cr-10134) by counsel appointed pursuant to the Criminal Justice Act (18 U.S.C. § 3006A). On appeal to the First Circuit (No. 18-1098), the petitioner retained undersigned counsel with third-party assistance. On subsequent remand to the District Court (No. 16-cr-10134), undersigned counsel was appointed to represent Petitioner pursuant to the Criminal Justice Act. *See* Ex. A (copy of Docket face page

reflecting designation of undersigned counsel as “CJA Appointed” and page containing Docket Entry 219 dated July 12, 2019, granting motion to appoint counsel on remand from First Circuit).

Because counsel was appointed in the court below pursuant to the Criminal Justice Act, no affidavit or declaration of the petitioner is attached. *See* S. Ct. R. 39.1.
