



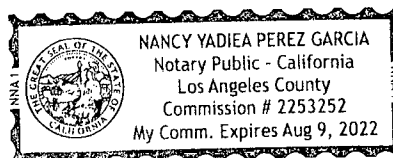

AFFIDAVIT of Lorilee House

On November 22, 2015, Willie House and I attended a Court session in the courtroom of the Honorable Eric M. Nakata (hereinafter referred to as "Jurist"), 14455 Civic Drive, Victorville, CA 92392.

The Jurist asked Mr. House to state his full name and address. When my husband gave his full name and address, as stated on his Driver License, or State Identification card, the Jurist asked whether Mr. House was sure this address was correct.

The Jurist asked whether the street name included the word "West."

At that point, Mr. House presented his identification and handed it to his attorney, who then read out the address exactly as my husband had spoken it a moment earlier, specifically, the same address listed on his identification.

When we requested a copy of the court transcript of this court session, the Court Reporter, Ms. Glenora Melendez, obviously having no personal interest in this matter, (speculation is that her subsequent action was done most probably at the direction of the Jurist), had removed the Jurist's questions from the transcript as well as Mr. House's attorney's reading of the address, said transcript, in turn, identifying Mr. House as having given the wrong address.

The transcript indicated that the matter was resolved by presentation of the California Driver License.

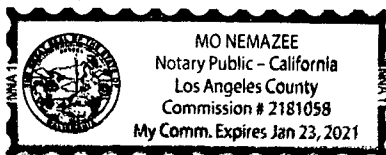

Federal, State and Local Judges Incarcerated for Crimes

Judge Eric Lyle Williams

“Ex-judge sentenced to death in Texas revenge plot

ROCKWALL, Texas — A former Texas justice of the peace received a death sentence Wednesday for the 2013 killing of a Texas district attorney's wife.

Eric Williams was convicted earlier this month of capital murder in the death of Cynthia McLelland, 65, the wife of Kaufman County District Attorney Mike McLelland, 63, who also was killed. The couple was killed in their home on March 30, 2013.”

“On January 31, 2013, Mark Hasse was shot and killed while walking in the 100 block of East Grove Street in Kaufman, Texas. Hasse was the Chief Assistant District Attorney for the Kaufman County Criminal District Attorney's Office. He was walking from his car to the courthouse when a gunman shot him repeatedly and then fled the area in a waiting car.^[3] Hasse, 57, had been an attorney for many years and had previously served as an Assistant District Attorney in Dallas County under District Attorney Henry Wade. He had worked for Kaufman County since 2010 as a prosecutor, and was also a licensed police officer commissioned with the District Attorney's office.^[citation needed] [...]

On March 30, 2013, the bodies of Kaufman County Criminal District Attorney Michael McLelland, 63, and his wife Cynthia, 65, were found in their home located in Talty in rural Kaufman County. Both had been shot and killed in what was described as a home invasion-type assault on their property.^[5]

McLelland had been elected to his office in 2010 and was widely viewed as an excellent replacement for the previous District Attorney, who had been arrested for driving under the influence while in office.^[6] Mike McLelland was an officer in the U.S. Army Reserve for 23 years, while Cynthia McLelland was a well-respected nurse at Terrell State Hospital, a mental health facility for the state.^[citation needed]

Following the McLelland murders, numerous elected officials in the county were placed under protection by law enforcement officers at home and at work. Security was visibly increased at the Kaufman County Courthouse.^[5]

Arrests and trial

On April 18, 2013, Eric Lyle Williams and his wife, Kim,^[7] were arrested for all three murders. Eric Williams, a former attorney and Justice of the Peace for Kaufman County,

had been convicted of burglary and theft while in office, and had been prosecuted by McLelland and Hasse. Williams was out of jail on probation at the time of the murders.^{[8][9]}

The trial was moved out of Kaufman County, as his defense lawyers cited media coverage and its interference of a fair trial as reasons for change of venue.^[10] Williams' estranged wife was held at the Kaufman County Law Enforcement Center in lieu of a \$10 million bond.^[10] Williams' license to practice law was suspended on October 10, 2012, and was permanently revoked when he was disbarred on February 3, 2014.^[11]

US District Judge Walter Nixon

“**Walter Louis Nixon Jr.** (born December 16, 1928) is a former United States District Judge of the United States District Court for the Southern District of Mississippi who in 1989 was impeached by the House of Representatives and removed from office by the Senate.^[2] Because Nixon's impeachment was for perjury, the case was cited as a precedent in the impeachment trial of President Bill Clinton.^{[3][failed verification][4]}

Nixon was convicted in 1986 on perjury charges and sentenced to 5 years in prison. The offense stemmed from his grand jury testimony and statements to federal officers concerning his intervention in the state drug prosecution of Drew Fairchild, the son of Wiley Fairchild, a business partner of Nixon. Although the case was assigned to a state court, Wiley Fairchild had asked Nixon to help out by speaking to the prosecutor. Nixon did so, and the prosecutor, a long-time friend, dropped the case. When Nixon was interviewed by the Federal Bureau of Investigation (FBI) and the United States Department of Justice, he denied any involvement whatsoever. Subsequently, a federal grand jury was empaneled and he again denied his involvement. He was convicted of making false statements to a grand jury.^[1] In 1989, he was impeached by the United States House of Representatives and convicted by the Senate, for committing perjury before a grand jury. Upon his conviction by the Senate, he was removed from office.^[5]

Nixon appealed his impeachment and removal to the United States Supreme Court. In *Nixon v. United States*, handed down in 1993, the Court rejected his appeal as a nonjusticiable political question.^[6] He returned to private practice in Mississippi from 1993 to 1998. He has practiced law in Lake Charles, Louisiana since 1998.^[2] ”

US District Judge Samuel B. Kent

“**Samuel B. Kent** (born June 22, 1949)^[1] is a former United States District Judge of the United States District Court for the Southern District of Texas, who served in the single-judge Galveston Division covering Brazoria, Chambers, Galveston,

and Matagorda Counties. A member of the Republican Party, he was nominated by President George H. W. Bush on August 3, 1990, to a seat vacated by Hugh Gibson, confirmed by the United States Senate on September 28, 1990, and received his commission on October 1, 1990. His tenure as a United States District Court judge was marred from 2001 on by a series of disciplinary actions, culminating in his impeachment and resignation in 2009.^{[2][3]}

On May 11, 2009, Judge Kent was sentenced to 33 months in prison for lying to investigators about sexually abusing two female employees. Dick DeGuerin, Kent's attorney, said the judge would retire from the bench because of a disability, rather than resign, which would have enabled Kent to continue to receive his \$169,300 annual salary for life.^[4] That did not satisfy the leaders of the House Judiciary Committee, Representatives John Conyers Jr., (D-Mich.) and Lamar Smith (R-Tex.), who demanded that Kent resign immediately or face impeachment.^{[5][6]}

Judge Kent submitted his resignation on June 2, 2009, with the provision that it would not take effect for a full year. This angered the membership of the House Judiciary Committee, which voted unanimously to send four Articles of Impeachment to the full House of Representatives on June 10, 2009.^[7] The articles were passed on June 19, 2009,^[8] making Judge Kent the first federal judge to be impeached since Walter L. Nixon, Jr. in 1989.^[9] Kent thereafter submitted a new letter of resignation to the Senate on June 25, 2009, taking effect on June 30, 2009.^{[10][11]} On June 30, President Barack Obama accepted his resignation.^[12] On July 20, the House of Representatives passed a resolution^[13] asking the Senate to end former Judge Kent's trial. Two days later, the Senate agreed to the resolution.^[14] “

US District Judge Harry E. Claiborne

“**Harry Eugene Claiborne** (July 2, 1917 – January 19, 2004) was a United States District Judge of the United States District Court for the District of Nevada from 1978 until his impeachment and removal in 1986. Appointed by President Jimmy Carter in 1978, Claiborne was only the fifth person in United States history to be removed from office through impeachment by the United States Congress and the first since Halsted Ritter in 1936. He was the first federal judge to be sent to prison. [...]

Claiborne was convicted in 1984 of tax evasion and served 17 months of a two-year prison sentence before his release in 1987. In 1986 the United States House of Representatives impeached him and the United States Senate convicted him and removed him from office. His impeachment proceedings set a controversial new precedent of using a special twelve-member committee to collect and hear evidence, rather than the full Senate. He maintained that the Justice Department had a vendetta against him and improperly obtained the false testimony of brothel owner Joe Conforte, one of Claiborne's former clients.”

Judge John W. Brady

“**John W. Brady** (April 6, 1869 or 1870 – December 14, 1943) was an American lawyer. He served as a county attorney from 1902 to 1910, the assistant attorney general for the state, and a judge on the Texas Third Court of Civil Appeals. In 1929 he was convicted of murder, and sentenced to three years in prison. [...]

In November 1929, in a case that garnered front-page headlines, Brady killed his 28-year-old mistress, Lehlia Highsmith.^[130] Arriving drunk at her boarding house around midnight on the 9th, he got into an altercation with those there, and then stabbed Highsmith to death when she turned up escorted by another man.^[130] Brady was tried twice.^[131] After a first trial ended in a hung jury, Brady was convicted of murder without malice in a second trial, and sentenced to three years in prison.^[131]”

Judge Lance Mason

“**Lance Timothy Mason** (born August 26, 1967) is a convicted murderer, former politician, government official, and judge, who served in various offices in and representing Cleveland, Ohio.

As a judge, he served on the Cuyahoga County Court of Common Pleas. He was a member of the Ohio Senate, representing the 25th District from 2007 to 2008. From 2002 to 2006, he was a member of the Ohio House of Representatives, where he served as Assistant Minority Whip during his final year. He was also an assistant prosecuting attorney for the county and was an aide to U.S. Representative Stephanie Tubbs Jones. In 2017, he worked as an official for the city of Cleveland under mayor Frank G. Jackson. [...]

Legal issues

On August 2, 2014, Mason was arrested and accused of beating his wife while he was driving and their children were in the backseat.^{[4][5]} Later that day, police seized ammunition and weapons from Mason's home, including shotguns, semiautomatic rifles, handguns, smoke grenades, a bulletproof vest, a sword, and over 2,500 rounds of ammunition.^[4] The couple, who were married in 2005, had separated the previous March.^[6] Their divorce was finalized on November 12, 2015.^[7] Mason pleaded guilty on August 13, 2015, to attempted felonious assault and domestic violence, and agreed to serve time in prison. On September 3, the Ohio Supreme Court suspended Mason from practicing law for being a convicted felon. Mason submitted his resignation as judge on September 15. The next day, he was sentenced to two years in prison; he was released after 9 months.^[8] During sentencing, the judge read from a police report which detailed how Mason punched his wife 20 times with his fist, smashed her head against the car's center console

five times, and continued to beat her, bite her, and threaten her after she exited the car. As a convicted felon, Mason will never be allowed to serve as a judge in the future, but could practice law depending on the outcome of disciplinary action by the state Supreme Court.^[9]

Murder charge

On November 17, 2018, Mason stabbed his ex-wife to death at a house she owned and in front of their two children.^{[10][11]} Mason took his ex-wife's SUV and fled the scene, striking a police cruiser and injuring the police officer inside before he was arrested.^{[8][11]} On August 20, 2019, he pleaded guilty and on September 12th, he was sentenced to life in prison with the possibility of parole after 35 years.^[11] ”

Judge Daniel McDonald

Former Lafayette County Circuit Judge Daniel McDonald was accused of bludgeoning James Klein, 31, with a metal bar and then stabbing him on June 22 in his law offices in Darlington, Wis.”

“DARLINGTON, Wis. (AP) A judge who died while serving a life sentence for the murder of a political foe’s law partner committed suicide, a coroner ruled Thursday.

Daniel McDonald, who died Monday at the Dodge County Correctional Facility in Waupun, took a fatal overdose of a drug that had been prescribed for his stress, said John Omen, the county coroner. The death of McDonald, 43, was listed initially as a heart attack.”

Judge Thomas J. Maloney

“**Thomas J. Maloney** (1925–2008) was a judge in Cook County, Illinois who served from 1977 until his indictment for bribery in 1991. Since 1981, the court was being investigated by the FBI in Operation Greylord,^[1] and he was eventually convicted^[2] on four counts of accepting bribes (including fixing three murder cases). He served 12 years of a 15-year prison term from 1994 to 2007.^[3] [...]”

The web magazine Judiciary Report has said of Maloney that he "easily qualifies as one of the worst judges in history".^[4] [...]”

In 1988, the FBI pressed charges based on Operation Greylord and the associated Operation Gambat, and a grand jury proceedings were initiated. Erstwhile bagman Robinson testified, under a grant of immunity. At the time, Maloney was continuing to practice.

In June 1991, Maloney was indicted, causing considerable surprise in Cook County. In the ensuing trial, he claimed in his defense that Swano and Robinson had operated a scam known as "rainmaking," where the participants never pass the bribe along to the judge. However, Maloney's financial records indicated that he had purchased "hundreds of money orders with cash from unknown sources",^[5] in order to hide the fact that he was spending more money than he received from all legitimate sources. On April 16, 1993, the jury convicted Maloney on all counts.^[10] ”

Judge Allen Loughry

“**Allen Hayes Loughry, II** (born August 9, 1970) is a former justice on the Supreme Court of Appeals of West Virginia.

Loughry was arrested by the FBI in 2018 after being indicted by a grand jury. In October 2018, he was convicted on 11 federal offenses, specifically wire fraud, making false statements to federal investigators, witness tampering and mail fraud.^{[3][4]} The following month, after facing impeachment, Loughry resigned from office.^{[5][6]} [...]

Federal prosecution and conviction

In late 2017, reports came to light of high spending by Loughry and Justice Robin Davis totaling well more than a million dollars,^[14] and at an emergency meeting, he was replaced as Chief Justice by Justice Margaret Workman.^[15]

On June 20, 2018, he was arrested at his home by the FBI, and later in the day Michael B. Stuart, United States Attorney for the Southern District of West Virginia, announced that a grand jury had indicted Loughry on 22 counts, including 16 counts of frauds and swindles, two counts of wire fraud, one count of witness tampering, and three counts of lying to federal investigators.^[16]

Loughry's federal criminal trial began on October 2. The trial concluded ten days later with Loughry being convicted of seven counts of wire fraud, one count of mail fraud, one count of witness tampering and two counts of lying to the FBI. The jury found Loughry not guilty on nine counts of wire fraud and two counts of mail fraud. They also deadlocked on one count of wire fraud after United States District Judge John Copenhaver refused to issue an Allen charge to the jury concerning this count. Loughry was sentenced to 24 months in federal prison on February 13, 2019 and is currently an inmate of FCI Williamsburg in South Carolina. ^[17] ”

“**Mark Arthur Ciavarella Jr.** (born March 3, 1950) is a convicted felon and former President Judge of the Luzerne County Court of Common Pleas in Wilkes-Barre, Pennsylvania who was involved, along with fellow judge Michael Conahan, in the “Kids for cash” scandal in 2008.^[4]

In August 2011, Ciavarella was sentenced to 28 years in federal prison for his involvement in the Kids for Cash scandal.^[5] **Mark Arthur Ciavarella Jr.** (born March 3, 1950) is a convicted felon and former President Judge of the Luzerne County Court of Common Pleas in Wilkes-Barre, Pennsylvania who was involved, along with fellow judge Michael Conahan, in the “Kids for cash” scandal in 2008.^[4]

In August 2011, Ciavarella was sentenced to 28 years in federal prison for his involvement in the Kids for Cash scandal.^[5]”

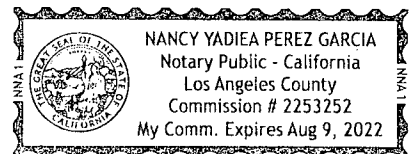
