

REQUEST FOR COURT ORDER OR ACCEPTANCE

Petitioner Matthew Castro, pro se, moves this Honorable Court for an order to the Florida Department of Corrections Mailroom Official here at Hamilton Correctional Institution Annex to furnish Matthew Castro with a notarized statement or declaration setting forth the date of the mailing of Matthew Castro's "Petition for Writ of Certiori" that was mailed out on April 15th, 2019 along with the Motion for Extension of Time, or for this Honorable Court to accept the Florida Department of Corrections Legal Postage Obligations sheet showing the April 15th, 2019 date, that was attached to the request that Matthew Castro filed to be able to comply with the obligation set down in the letter sent to him by the Clerk Scott S. Harris dated August 12th, 2019. (See attached letter dated August 12th, 2019).

In support Petitioner states the following:



1. That Matthew Castro sent an inmate request asking if the mailroom here at Hamilton Correctional Annex would provide him with a copy of his outgoing legal mail for the month of April 2019 and all he got in return was this Legal Postage Obligation sheet showing his mailing on April 15th, 2019 to this Honorable Court Julie Carnes Supreme Court of the United States, 1 First Street N.E., Washington, District Court. 2. That he Matthew Castro had put postage on his Petition for Writ of Certiori and did not have enough postage for his Motion for Extension of Time that was mailed at the same time.

3. Matthew Castro files this “Request” in good faith to be able to comply with this Honorable Court’s letter sent to him by the Clerk of Court on August 12th, 2019.

4. Petitioner also respectfully request that this Honorable Court accept that once an inmate puts his legal mail in the hands of a mailroom official it is considered timely filed. See Thompson v. Montgomery, 853 F.2d 287 (5th Cir. 1988) Cert. denied 488 U.S. 1014 (1989).

WHEREFORE Petitioner respectfully moves this Honorable Court to understand his situation and seeks this Courts help in accomplishing the task set out by this Court in acquiring the documentation notarized showing his mailing of his Petition For Writ of Certiori mailed on April 15th, 2019.






