## **MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***

Petitioner, Lisa Marie Montgomery, seeks leave to file the enclosed Petition for Writ of Certiorari without prepayment of costs and to proceed *in forma pauperis* in accordance with Supreme Court Rule 39.

The United States District Court for the Western District of Missouri found Mrs. Montgomery indigent and permitted her to proceed *in forma pauperis*. Counsel are appointed pursuant to 18 U.S.C. § 3006A and 18 U.S.C. § 3599.

The filing of this petition is a continuation of counsel's representation of Mrs. Montgomery under the 18 U.S.C. §3599(a)(2) appointment. See 18 U.S.C. § 3599(e) ("[e]ach attorney so appointed shall represent the defendant throughout every subsequent stage of available judicial proceedings, including ... applications for writ of certiorari to the Supreme Court of the United States"). In accordance with Supreme Court Rule 39, no affidavit declaring Mrs. Montgomery's indigency is required.
