QUESTION PRESENTED FOR REVIEW

Whether the Eleventh Circuit Court of Appeals committed error in its affirmance of the District Court's denial of Petitioner Jose Romeu's 18 U.S.C. § 3582(c)(2) motion for sentence reduction under Amendment 599 to the United States Sentencing Guidelines where the offense did not include a firearm charge and further declined to reconsider his motion for sentence reduction under Amendment 782 where the District Court ignored unresolved objection to the Presentence Investigation Report("PSI") where the memorandum of sentencing hearing and report of statement of reasons did not include a drug amount..
