MOTION TO PROCEED *IN FORMA PAUPERIS*

Petitioner moves the Court to proceed *in forma pauperis* on his petition for a writ of certiorari.

The case was first filed in the Eastern District of Arkansas, and the District Court granted Petitioner's motion to proceed *in forma pauperis* pursuant to 28 U.S.C.

§ 1915(b)(1) on March 17, 2017, although the court also ordered he pay \$2.53 toward the filing fee under the Prison Litigation Reform Act. The case was then transferred to the Western District of Arkansas, the correct venue.

Counsel was appointed by the Court of Appeals for the Eighth Circuit pursuant to 28 U.S.C. § 1915(e)(1) on June 29, 2018 for briefing and oral argument.

ORDER

Plaintiff Adam Lane's motion to proceed *in forma pauperis* [Doc. No. 1] is granted, but he must still pay the full statutory filing fee of \$350. 28 U.S.C. § 1915(b)(1). Based on the information contained in his motion, Lane's initial partial filing fee is \$2.53. Regardless of account balance, the director of the Arkansas Department of Correction ("ADC") shall withdraw any portion of the partial filing fee available, and continue to do so until the partial fee has been paid in full. Upon payment of the initial partial filing fee, the director shall withdraw monthly payments in the amount of twenty percent of the preceding month's income credited to his account each time the account exceeds \$10 until the statutory fee has been paid in full.

The clerk is directed to send a copy of this order to the Arkansas Department of Correction Compliance Office, P.O. Box 20550, Pine Bluff, AR 71612; to the ADC Trust Fund Centralized Banking Office, P.O. Box 8908, Pine Bluff, AR 71611; and to the warden of the Cummins Unit, P.O. Box 500, Grady, AR 71644. Payments shall be forwarded to the clerk of court with Robinson's name and case number clearly identified.
