The United States Court of Appeals for the Ninth Circuit;

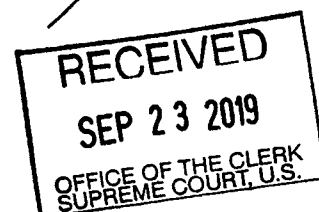


