MOTION SEEKING LEAVE TO PROCEED IN FORMA PAUPERIS

COMES NOW, Kevin Skaggs, pro-se, an indigent inmate in the Kansas Department of Corrections, and requests this Court to allow him to proceed in forma pauperis with his Petition for Writ of Certiorari for the following reasons:

1. Mr. Skaggs is indigent, has no job, no source of income, no property, real or personal, and no assets of any kind.
2. Mr. Skaggs has proceeded pro-se in filing his original Writ of Habeas Corpus in the State of Kansas in his attempt to obtain relief from his wrongful conviction.
3. Mr. Skaggs has proceeded pro-se and in forma pauperis in his appeal to the Tenth Circuit Court of Appeals in his attempt to obtain relief from his wrongful conviction.
4. Mr. Skaggs does not possess the resources to pay the \$300.00 fee that is due with the Petition.
5. Mr. Skaggs does not possess the resources to prepare and send 40 copies of the petition to the Court, nor serve any copies on the opposing party.

WHEREFORE, Mr. Skaggs prays this court will allow him to proceed in forma pauperis with his Petition for Writ of Certiorari in his attempt to obtain relief from his wrongful conviction.
