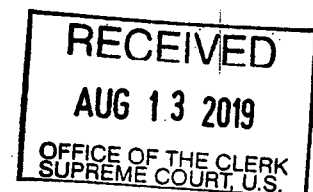

Pursuant to 1st Cir. R. 27.0(d)

This is an appeal from the dismissal of an action brought by plaintiff against, *inter alia*, the Puerto Rico Department of Education. On May 3, 2017, the Commonwealth of Puerto Rico filed a petition under Title III of the Puerto Rico Oversight, Management, and Economic Stability Act (PROMESA), 48 U.S.C. § 2161, *et seq.*, for adjustment of its debts. Under section 2161(a), the bankruptcy stay provision of 11 U.S.C. § 362 is incorporated into PROMESA. In light of the Commonwealth's PROMESA filing, we direct the parties to show cause within fourteen days of the date of this order whether the automatic stay applies to all or any part of this appeal. The parties are directed to state with specificity the reasoning behind their conclusion one way or the other.
