MOTION TO PROCEED IN FORMA PAUPERIS

The Petitioner asks leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed in forma pauperis.

Petitioner has previously been granted leave to proceed in forma pauperis for his case in the United States District Court for the Northern District of Georgia, in case no. 1:10-CR-053, and for his direct appeal in the United States Court of Appeals for the Eleventh Circuit, in appeal no. 12-12255. A copy of such Order is not appended, as the Petitioner does not have a copy of it; but this Court does have record of such Order, as it was appended in the Petitioner's previous filing of writ of certiorari, which can be found in Supreme Court case no. 13-9836, STERLING v. UNITED STATES. (However, in Petitioner's latest filing to the Eleventh Circuit, requesting issuance of a certificate of appealability, the Petitioner's mother paid the court and filing fees).

The Petitioner is also attaching a copy of a page from his District Court docket sheet which shows that entry no. #16, on 2/9/10, an "Order of CJA 20-Appointment to Pay Court Appointed Counsel as to RONN STERLING?" [This is Petitioner's only proof that he has previously been granted in forma pauperis status that is within his possession]. Thank you.
