



Petitioner on writ of certiorari Linh Thi Minh Tran preserved Respondent on writ of certiorari Stan the Hot Water Man was not appropriate for summary judgment by petitioner on writ of certiorari Linh Thi Minh Tran submitted to trial court her deposition of Linh Thi Minh Tran in support of petitioner on writ of certiorari Linh Thi Minh Tran in opposing to respondent on writ of certiorari Stan the Hot Water Man's motion summary judgment. In addition, petitioner on writ of certiorari Linh Thi Minh Tran submitted to trial court petitioner on writ of certiorari Linh Thi Minh Tran's opposing and objection to trial court Multnomah County Circuit Court State of Oregon's decision granting in favor of respondent on writ of certiorari Stan the Hot Water Man's motion summary judgment. The trial court Multnomah County Circuit Court granted the respondent on writ of certiorari Stan the Hot Water Man's motion summary judgment, as reflected in the

general judgment of dismissal. Plaintiff Linh Thi Minh Tran filed Notice of Appeal to Oregon Court of Appeal.

The trial court Multnomah County Circuit Court granted the general judgment of dismissal in favor of defendant Stan the Hot Water Man was error in significant issue of law about the use or effect of rule of trial court procedure ORCP 47C. Motion for summary judgment; the error of trial court is the legal issue of Oregon State law, and this case is the same or related issue was ruled by the Oregon Supreme Court. The Oregon Court of Appeals's decision appears to be error results in a serious or irreversible injustice or in a distortion or misapplication of a legal principle.

ARGUMENTS

Q Okay. And when you were going there you had no idea what the exact problem was you'd encounter with the heater—

A Correct.Correct.

Q --Correct?

Q Okay. So, you show up at the house and go into the through large garage door and examine the hot water heater, correct?

A Yes. Correct?

Q And you determined in your examination that the thermocouple needed to be replaced—

A Correct.

Q Correct?

B. Did you then give any kind of written estimate or invoice at that point to Ms. Tran saying is how much this will cost?

A No.

Q And it's true, isn't it, that the only time you submitted a bill for payment was after you installed the thermocouple?

A Correct.

Q Okay.

Based on the Brent Philip Lackey testified at the hearing trial in Clackamas County Court, plaintiff State of Oregon lack of merit to file complaint against defendant Linh Thi Minh Tran Clackamas County Circuit Court Case Name: State of Oregon vs. Linh Thi Minh Tran, Clackamas County Circuit Court Case Number: 16CR03390, Oregon Court of Appeals Case Number: A166004, Oregon Supreme Court Case Number: S066461 because Brent Philip Lackey testified that he took the part from defendant Linh Thi Minh Tran's hot water heater results the gas hot water heater was leaking, and the gas furnace was burning blow machine very dangerous and very risk and fire. Based on Respondent on writ of certiorari Stan the Hot Water Man's answer, affirmative defenses and counterclaims submitted to trial court on July 5, 2016 in which Defendant Stan the Hot Water Man said: "Stan the Hot Water Man admits that Mr. Lackey visited 12542 SE Capella Court, Happy Valley, Oregon (the "property") on December 23, 2015, in response to a request for service at that address." From this paragraph, petitioner on writ of certiorari Linh Thi Minh Tran was able to determine there is an employer-employee relationship exists between employer Stan the Hot Water Man and employee Brent Philip Lackey, therefore, the doctrine of respondeat superior allows the law to hold an employer Stan the Hot Water responsible for the acts of an employee Brent Philip Lackey. Also, Stan the Hot Water admitted that Brent Philip Lackey visited 12542 SE Capella Court, Happy Valley, Oregon on December 23, 2015, in response to a request for service hot water heater at that address, **therefore, it is a matter of law to hold defendant Stan the Hot Water Man responsible for the all wrongful, risks, and dangerous acts were committed of Brent Philip Lackey on December 23, 2015 at 10:00 a.m at plaintiff Linh Thi Minh Tran's property address 12542 SE Capella court, Happy Valley, Oregon 97086 within the scope and course of his employment and at the direction of his employer Stan The Hot Water Man. Petitioner on writ of certiorari Linh Thi Minh Tran has never known Brent Philip Lackey before the incident occurred on December 23, 2015.** And Brent

Because Brent Philip Lackey acted very dangerous, so Petitioner on writ of certiorari Linh Thi Minh Tran must turn the gas shut-off valve to OFF to avoid damage and fire. Unfortunately, at that time Brent Philip Lackey used wrench to push petitioner on writ of certiorari Linh Thi Minh Tran away results caused the blower motor and starter windings of gas furnace were burnt out and fired caused the house did not have heat in few days and the costs to repair the gas furnace blower motor was \$485.00 and petitioner on writ of certiorari Linh Thi Minh Tran's suffers physical injuries, damages, and her life-threatened and her mental health has serious anxiety problems.

Assault is defined as “an intentional attempt to do violence to the person of another coupled with present ability to carry the intention into effect.” Here, according to video records, audio, and youtube links that petitioner on writ of certiorari Linh Thi Minh Tran submitted to Multnomah County Circuit Court on 06/27/2017 and served to Marjorie Elken, Attorney of defendant-respondent Stan the Hot Water Man according to order of Multnomah County Circuit Court Judge James Bronson, The videos and audios to determine Brent Philip Lackey, employee of defendant Stan did unlawfully intentional attempt to do violence, created a risk of inconvenient in petitioner on writ of certiorari Linh Thi Minh Tran’s property at 12542 SE Capella court, Happy Valley, Oregon 97086 by Brent Philip Lackey did fighting/violent, tumultuous, risks, dangerous, assault, destroyed and stole parts of petitioner on writ of certiorari Linh Thi Minh Tran’s hot water heater and threatening behavior to petitioner on writ of certiorari Linh Thi Minh Tran as results petitioner on writ of certiorari Linh Thi Minh Tran was risk of injury and damages and the house was almost burned and fired at that time.

In *Schmidt v. Archdiocese of Portland in Oregon*, 235 Or App 516, 520-21, 234 P3d 990 (2010). “*an employer is vicariously liable for an employee’s tortious conduct, including intentional torts, when the employee acts within the scope of employment.*” Under doctrine of respondeat superior, an employee is acting in the course and scope of their employment if: “*(1) The act occurred substantially within the time and space limits authorized by the employment;*

Respondent on writ of certiorari Stan the Hot Water Man also admitted that The Company Stan The Hot Water Man assigned Brent Philip Lackey to fix hot water heater at plaintiff Linh Thi Minh Tran’s home on December 23, 2015 at 10:00 a.m, located at 12542 SE Capella court, Happy Valley, Oregon 97086. Respondent on writ of certiorari Stan the Hot Water Man admitted Brent Philip Lackey arrived at plaintiff Linh Thi Minh Tran’s property on December 23, 2015, at approximately 10:00 AM within the time and space authorized by his employment. Brent Philip Lackey used his tools wrench, hammer, and knife to destroy and took out parts of petitioner on writ of certiorari Linh Thi Minh Tran’s hot water heater and set up high limiting blower machine of gas furnace, stole/took out the parts and materials of hot water heater without any consent or knowledge of petitioner on writ of certiorari Linh Thi Minh Tran. Brent Philip Lackey’s misconduct was not only reprehensible and outrageous and in total disregard of petitioner on writ of certiorari Linh Thi Minh Tran’s owner rights of property. In *Chesterman v. Barmon*, 82 Or App 1, 4, 727 P2d 130, 131 (1986), aff'd and rem'd, 305 Or 439 (1988) (citing *Brennen v. City of Eugene*, 285 Or 401, 405, 591 P2d 719 (1979)). In the employment context, “an employer whose employees come into contact with members of the public during their employment is responsible for exercising a duty of reasonable care in the selection...of its employees.” Id. In *Chesterman*, the court went on to state: “Liability is for negligence placing an employee **with known dangerous propensities, or dangerous propensities which could have been discovered by a reasonable investigation**, in a position where it is foreseeable that he could injure the plaintiff in the course of the work. The duty to use reasonable care in hiring or retaining employees arises because it is foreseeable that the employee, in carrying out his employment, may pose an unreasonable risk of injury to others.” Indeed, defendant Stan The Hot Water Man owed a duty of reasonable care in the selection of its employees and if respondent on review Stan the Hot Water Man was negligence in its hiring or carrying out its employment, may pose an unreasonable risk of injury to petitioner on writ of certiorari Linh Thi Minh Tran. Here in this case, respondent on writ of certiorari Stan the Hot Water Man admitted in declaration of Michael Spicer that it breached of duty of reasonable care in its hiring Brent Philip Lackey because it was not aware of any issues in Brent Philip Lackey’s background or Brent Philip Lackey’s criminal history records or Brent Philip Lackey’s mental health issues and because of its negligence created a risk of injury, annoyance, and fighting/violent, tumultuous, and threatening behavior as results plaintiff Linh Thi Minh Tran was risk of injury and damages.
