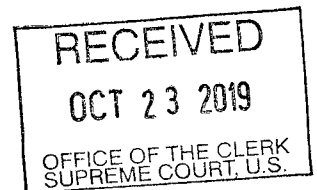
DECLARATION OF TIMELY FILING

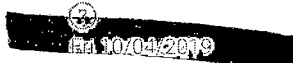
