

The petitioner was an architect. She lost her ability to abstract thinking and was unemployed in China in March 2016. The petitioner returned to the United States to sue personal injuries on September 7, 2017. resulting in the decline of HShi's GPA. The daughter's future was destroyed. HShi informed the school that it will suspend its school in the fall on June 7, 2019. No money to pay for tuition.
