PETITION FOR REHEARING

Xuejie He("Petitioner"or "He") , Heyangjing Shi ("Petitioner"or "Shi") , seeks rehearing of the court's opinion in the above case filed on January 13, 2020. The rehearing is necessary because:

1. The lower court of appeal denied motion the poor person to leave to appeal to the court of appeals, deprives Petitioner of appeal right , directly conflict with Due Process Clause and the Equal Protection Clause of the Fourteenth Amendment to the United States Constitution.

Has so far departed from the accepted and usual course of judicial proceedings, sanctioned such a departure by a lower court, as to call for an exercise of this Court's supervisory power.

2. When a case is between two or more states, the Supreme Court holds both original and exclusive jurisdiction, and no lower court may hear such cases by 28 U.S. Code § 1251(a)(b)(3).

- He won't file a tort claim in New York.

- the courts of New York have no jurisdiction over New Jersey government entity and corporations entity. Similarly,
- New Jersey courts have no jurisdiction over New York government entity and corporations entity. But
- New York infringement was the result of New Jersey infringement. Because Petitioner He lived and worked in China.

3. Limitation of action. Never granted motion the poor person from the low Court, no lawyer, no translator for my action of papers, only google translate.

Petitioner requests that rehearing be granted and that the court the petition for a writ of certiorari should be granted.
