To the Supreme Court of the United States:

John Henry Ramirez, a Texas death row inmate, respectfully seeks leave to proceed *in forma pauperis*. With this motion he has filed a petition for a writ of certiorari to the United States Court of Appeals for the Fifth Circuit.

Mr. Ramirez is indigent. He has been incarcerated since his arrest and always had court-appointed lawyers. Mr. Kretzer and Mr. Allen were appointed by the Fifth Circuit under the Civil Justice Act of 1964, 18 U.S.C. § 3006A, to represent

him in his federal habeas action. Neither lawyer received any funds, or the promise of any funds, from any other source other than under the Act for payment of legal fees for his habeas action.

For the reasons set forth above, Petitioner respectfully prays that this Court grant leave to proceed *in forma pauperis*.
