Pursuant to Supreme Court Rule 30.4, Respondent respectfully moves for an extension of the time for filing a response to the petition for writ of certiorari in *Jones v. Davis*, 19-6465.

The Petition was filed in this Court on October 28, 2019, and placed on the docket October 31, 2019. A response to the Petition is currently due on November 30, 2019.
