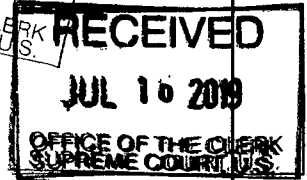
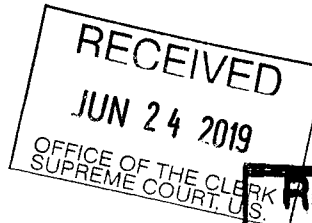

19 Please accept Petitioner, Arthur Lopez's
20 First Request for a 90 Day Extension to the
21 Deadline to file a Petition for Writ of
22 Certiorari. The current deadline to the
23 90 Day filing limitation from the California
24 Supreme Court's Denial of the Appellant's Petition for
25 Review of March 20th, 2019 is June 18th, 2019.
26 Petitioner is respectfully seeking this court's
27 granting to extend this deadline to
28 September 18th, 2019 for Good Cause.

1 Petitioner sustained traumatic injuries on December
2 22nd, 2015 which are permanent and caused temporary
3 paralysis. Consequently the permanent injuries and
4 disabilities have led to an absence of employment
5 income. Petitioner is also not represented
6 by counsel although this case stems from
7 a criminal (misdemeanor) case under Trial Court Case
8 # 15 H412251 and also despite Petitioner formally
9 requesting from the lower courts a court appointed
10 attorney for the Appeal Processes @ the Ca Court of
11 Appeals and California Supreme Court.
12 Moreover, Petitioner recently filed a Writ of
13 Habeas Corpus Petition with the Superior Court of
14 California, County of Orange @ 700 West Civic Center Drive;
15 Santa Ana, Ca 92701 related to the (2) misdemeanor
16 convictions following his Jury Trial under # 15 H412251.
17 This Habeas Corpus Petition was filed on May 2nd, 2019 Case # H18067
18 also without counsel.

19 In addition, Petitioner successfully met a
20 May 2nd, 2019 deadline imposed by this
21 court on the matter of "Lopez v Irvine Company, LLC"
22 by way of submitting the Petition for Writ of Certiorari.
23 Lastly, Petitioner has been required to appear
24 on a variety of days through May in the
25 Family Superior Court of California, County of Orange
26 @ the Lamoreaux Justice Center in efforts to
27 meet Hon. Judge Daphne Sykes conditions to Petitioner's
28 Parental Rights and Custody of his four children which

1 he has been deprived of seeing or even talking
2 to for over 3 1/2 years (Case # 16 D001283) despite
3 an overbearing ^{3rd} protective order imposed by the trial
4 court judge Thomas Delaney under Case # 15 HMI 2251
5 expiring January 14th, 2019.

6 In closing, Petitioner has disclosed other delay
7 tactics from the Superior and Court of Appeals
8 Courts and judicial officers to include
9 deprivation of Civil Rights provided by the
10 U.S. Constitution's 14th Amendment in
11 the previously submitted 60 Day extension
12 request under United States Supreme Court
13 Case/Docket # 18-A921.

15 For all these reasons and more Petitioner,
16 Arthur Lopez respectfully and humbly
17 requests a 90 Day Extension to File &
18 a Petition for Writ of Certiorari with
19 this court to September 18, 2019.
