
**ORDER**

Before us is Defendant's "Motion for Return of Property-Motion for Return of all Civil Rights." Following a status conference on May 30, 2018, IT IS HEREBY ORDERED as follows:

1. The Office of Attorney General and the Hazelton Police Department shall promptly return to Defendant, his Winchester "30/30" Rifle and the gun case for the said rifle.
2. The Court Administrator shall schedule a further half day hearing on the issue of the other items set forth in Defendant's Motion for Return of Property which the Commonwealth alleges are not in its possession.
3. In all other respects, we decline to consider Defendant's request that his civil rights "to include the right to bear, purchase, own and bear arms upon completion of his sentence" should be restored, pending Defendant's appeal of his conviction and because we do not believe we have jurisdiction over any of the law enforcement agencies which might impose any restrictions upon Defendant should his conviction be upheld.
