MEMORANDUM FOR THE UNITED STATES

Petitioner contends (Pet. 7-18) that his prior convictions for aggravated assault under Tenn. Code Ann. § 39-2-101(b) (1984) and Tenn. Code Ann. § 39-13-102(a)(1) (2002) do not qualify as violent felonies under the Armed Career Criminal Act of 1984, 18 U.S.C. 924(e)(2)(B)(i), on the theory that an offense that can be committed with a mens rea of recklessness does not include as an element the "use, attempted use, or threatened use of physical force against the person of another." This Court has granted review in Walker v. United States, cert. granted, No. 19-373 (Nov. 15, 2019), to address that question. The petition for a writ of certiorari should therefore be held pending this Court's decision

in Walker and then disposed of as appropriate in light of that decision.*
