- Answer to Question #12 - WHY I CANNOT PAY THE COSTS OF THIS CASE

I have been denied or cannot enforce in the courts of South Carolina a right under law providing for the equal civil rights of citizens of the United States, or within the jurisdiction thereof; and for acts under color of authority derived from laws providing for equal rights, and or for refusing to do such act on the ground that it is inconsistent with such laws, where government officials have obstructed and continue to obstruct my legitimate efforts to seek judicial redress and government officials have obstructed and continue to obstruct my access to court which has rendered my state court remedies impossible. The Court has inappropriately incurred pre-trial freezing of my legitimate untainted assets as a criminal defendant [See, Sumter Fam.Ct. No. 2015DR430046 ORDER Jan.20, 2015] (attached pp.9-10) and which has effected my misconviction and my poverty. I served indigent claim papers (IFP) upon JAMES C. CAMPBELL CLERK OF COURT (Clerk), Clerk ignored my IFP papers--failing to file them with the Court--at least seven (7) different times [See, S.C.Dist.Ct. Complaints, 6:18-2610-HMH, et al.] thwarting vindication of my claims and affecting the law of the case where I sent more than twenty (20) Moitons [Id.] to the Court which Clerk did not file with Court because Clerk did not follow State statutory law involving matters of indigency. South Carolina State Code of Law § 8-21-320. I complained about Clerk etc. to the County Court (Judge Taylor) by serving the County Court (Judge Taylor) directly but those papers were rejected by County Court's administrative assistant who returned my claims and forbid any further communication with the

Court [see, S.C. Sup.Ct. No.2019-000585]; effecting no access to Court. Government officials have so far departed from the accepted and usual course of judicial proceedings and have obstructed my legitimate efforts to seek judicial redress of my grievances where I was left no option but to bring those no court access claims to South Carolina Supreme Court, with such material prejudice to my rights and matters which cannot be determined in the lower court; but South Carolina Supreme Court denied those claims. See, ORDER dated October 8, 2019 S.C. Supreme Court 2019-001424 / 2018-001730.

The Sumter County Judicial Center is the only way I can access my property (money) to obtain counsel for defense from my criminal charges, my criminal conviction, appeals, PCR, false imprisonment, asset protection, divorce, trial, et al. Government has taken my property and has not paid compensation for that property, and has left me with no means to access the Court for redress of such grievance. I am not an attorney, nor do I understand the practice or science of law, I am unsure how to apply the Rules of Court like a trained practitioner would. With malfeasance of Clerk and forbidden Court access, I am left with no means at all to petition for a redress of grievances, and which redress of grievances I am entitled to. U.S. Const. Amends. I, V, XIV, Art. 4, § 2, cl. 1.

PREMISES CONSIDERED, I cannot pay the costs of this case. In support of my claims I declare under penalty of perjury the foregoing is true and correct.

Based upon a review of the Complaint and supporting Affidavit of the Plaintiff, it is apparent that there is a need for an emergency hearing as this involves the parties' assets and debts. 

ORDERED that the Defendant be restrained from bothering, abusing, threatening abuse, harassing or in any fashion interfering with the Plaintiff. It is further,


