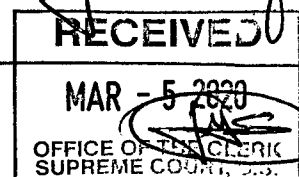
Smith v. Washington

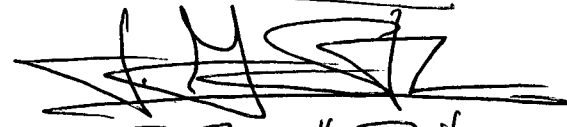
