

"final Judgment Order" by omitting *Sophia Stewart vs. Jonathan Lubell, et. al.*, 2:07-cv-00552-DB, **Docket 288**, thus imputing guilt under § USSG 2B1.1(8) (c), subsect. (b) (9) (C).



#### PROCEDURAL SUMMARY

Petitioner avers more than 41 Senior Government Officials from the Executive Branch, U.S. Department of Justice, Antitrust Division, or "Criminal Division" functions inside Covington & Burling, LLP, under the cloak of a "constructive trust" who to date are "unregulated by Congress, and unelected by the American people," while the perpetrators function as a "Shadow quasi-Branch" of the government, and continue to commit predicate acts of espionage offenses, as well as, altered the laws of the United States as "unregistered foreign agents" in violation of the Foreign Agents Registration Act of 1938 citing Title 22 U.S.C. § 611(2)(o). Petitioner avers said "Seditious Traitors" advertised a "service" on Covington &



Burling LLP's website to set up "backdoor" meetings for their Clients (*i.e.* Foreign Principals)<sup>16</sup> to illegally come into contact and have operated in concert to arrange for meetings with Senior Government Official from the Executive, Legislative or Judicial branches, thus warranting herein an "injunction" pursuant to 22 U.S.C. § 618(j):

On **November 4, 2019**, Petitioner avers "Silent Partner,"<sup>18</sup> Steven T. Mnuchin's<sup>19</sup> business partners Foreign Principals Twentieth Century Fox Film Corporation, Tencent Pictures (USA) LLC, Paramount Pictures Corporation, and Tim Miller filed a "false Oath of Ownership" for a Videocassette (HDcamSR), Registration Number PA0002210499,<sup>20</sup> in violation of FARA 1938, citing 18 U.S.C. § 152(2), cross-referencing USSG § 2J1.2. Petitioner asserts "Silent Partner"<sup>21</sup> / Secretary of State, Steven

Mnuchin, "Seditious Traitors"<sup>22</sup> Eric Holder, Thomas O. Barnett, Covington & Burling LLP, and George S. Cary, Cleary Gottlieb Steen & Hamilton maintained a pecuniary interest as Legal Principals while engaging in "political activities" to defeat the lawful administration and enforcement of the DOJ to enforce FARA 1938, thus violating 22 U.S.C. § 611(o), cross-referencing USSG § 2X3.1

On **January 30, 2019**, Petitioner avers "Silent Partner,"<sup>23</sup> Steven Terner Mnuchin, operated in concert to cover up his direct financial interest, and his business partners Gale Anne Hurd, Valhalla Entertainment Inc., Pacific Western Productions, Inc., David Ellison, Skydance Media, LLC, and Paramount Pictures Corporation filing a "False Oath of Ownership" for the "Terminator" movie franchise copyrights, Document Number V9961D557,<sup>24</sup> Entire Copyright Document V9961D557 P1-3, thus constituting a continuing breach and "criminal conflicts of interest"<sup>25</sup> prohibited under the Foreign Agents Registration Act of 1938, citing 22 U.S.C. § 618(e), cross-referencing USSG § 2C1.1(c)(2).

On **April 24, 2018**, Petitioner avers "Seditious Traitors" Eric Holder, Thomas O. Barnett, Covington & Burling LLP, and George S. Cary. "advertised" on the Department of Justice website a

consisting of Subversive Enemy Aliens," (i.e., Lachlan Murdoch,<sup>27</sup> and James Murdoch) in violation of Foreign Agents Registration Act (FARA) of 1938, Subversive Activities Act of 1950, The Hatch Act of 1939, 10 U.S.C. § 894(a)(2), Article 94, 18 U.S.C. §§ 2(b), 18 U.S.C. § 371, 951(a), Chapter 73, 18 U.S.C. § 1509, Title 18 U.S.C. § 1510(a), 1512(2)(B)(ii), 1512(k), 18 U.S.C. § 1341, 1342, 1343, 18 U.S.C. § 1519, 22 U.S.C. §§ 611(c)(1)(i), 611(c)(1)(ii), 611(c)(1)(iii), 611(c)(1)(iv), 611(2)(f), 611(2)(o), 611(2)(p), 22 U.S.C. § 612 et. seq. I. GROUND I: PETITIONER DANNEZ W. HUNTER IS THE ADMINISTRATOR THAT PERSONALLY SERVED TWENTY-FIRST CENTURY FOX, INC., KATE CHILTON, WARNER BROS. ENTERTAINMENT INC. WITH COPIES OF SOPHIA STEWART'S **\$3,500,000,000**, UNIFORM COMMERCIAL CODE LIEN, NO.: 09-7206985753,<sup>28</sup> AMENDMENT NO.: 09-72073370, WHERE THEREAFTER, COVINGTON & BURLING LLP THROUGH THIRD PARTY LEAH JANUS, FREDRIKSON & BYRON, P.A. CARRIED OUT AN ECONOMIC RETALIATORY CAMPAIGN TO STALK THE BLACK WHISTLEBLOWER OVER 9 YEARS, UNDER THE COLOR OF LAW, WHILE THE PERPETRATORS CONSPIRED TO ACT IN THE UNITED STATES AS UNREGISTERED FOREIGN AGENTS WHO WILLFULLY FAILED TO REGISTER AS MANDATED UNDER THE FOREIGN AGENTS REGISTRATION ACT OF 1938 ("FARA") CITING PROHIBITIONS UNDER 18 U.S.C. § 1509, cross-referencing 18 U.S.C. § 1513(e)(f):

No.: 19-6630, white nationalists on the United States Supreme Court, denied a "Writ of Certiorari," "operated in concert" with "Partisan political operatives" Ralph Erickson," Steven Colloton, and Jonathan Allen Kobes from the Eighth Circuit Court of Appeals who combined, confederated, and agreed to cover up espionage by **41** "Unregistered Foreign Agents" inside Covington &

Burling LLP," as the "Seditious Traitors" targeted a Black woman, Sophia Stewart, and the Whistleblower, over 9 years, as the Officers of the Court "permitted espionage" by Spies from a Communist party in the Commonwealth of Australia, as well as, "defeated and overthrew" the "lawful functions" of the United States Department of Justice to "administer and enforce" the "Foreign Agents Registration Act of **1938**," in violation of 22 U.S.C. § 611(2)(p).

Petitioner avers Foreign Terrorist Keith Rupert Murdoch's Fox Network is known for being a Communist white nationalist, far-right platform who has conspired to act in the United States with intent to defeat the lawful administration and enforcement of FARA 1938, while operating in the United States as a Malign Foreign Influencing Operation in violation of the Internal Security Act of 1950, citing 50 U.S.C. § 3021(h). Seditious Terrorist Keith Rupert Murdoch, Lachlan Murdoch, and James Murdoch, under the cloak of News Corp., and Fox News Network routinely villainizes people of color, and has altered the Department of Justice, policies, practices and procedures outlined inside the Criminal RICO: 18 U.S.C. 1961-1968, A Manual For Federal Prosecutors, while conspiring to act as a "Malign Foreign Communist Influencing Operation"<sup>29</sup> in the United States who has defeated the DOJ ability to enforce

**A. OBJECT OF THE CONSPIRACY**

Petitioner asserts said Seditious Traitors<sup>30</sup> Eric Holder, Thomas O. Barnett from Covington & Burling LLP, and George S. Cary, Cleary Gottlieb Steen & Hamilton willfully operated in concert to act in the United States as "unregistered foreign agents," who conspired to conceal their guile to steal federal intangible properties, and plotted to cover up Secretary of Treasury Steven Terner Mnuchin, U.S. Department of Treasury,<sup>31</sup> being a "Silent Partner,"<sup>32</sup> while in "Federal Service" and having a "direct financial interest" in the form of an "Agreement with Warner Brothers" valued at **\$25,000,000.00**,<sup>33</sup> a second "agreement with Warner Bros in the amount of **\$1,000,000.00**,<sup>34</sup> and covered up his "joint venture" by RatPac-Dune<sup>35</sup> Entertainment LLC, thus invoking prohibitions under the Ku Klux Klan Act, Third Enforcement Act, or Third Ku Klux Klan Act under H.R. 320 dated **March 28, 1871**, cross-referencing 5 CFR § 2640.103(2)(3)(i).

Petitioner avers "Silent Partner,"<sup>36</sup> Secretary of Treasury Steven

Mnuchin<sup>37</sup> abused his power, "controlling the paychecks"<sup>38</sup> of Nancy E. Brasel, David T. Schultz, Steven Colloton, Jonathan Allen Kobes, Clarence Thomas, and John Roberts Jr, who conspired to cover up failures to register under FARA, bribery payments being made to conceal offenses of espionage by the Democratic National Committee or obstructed justice with respect to racketeering criminal offenses by 10 or more members of a "foreign Communist political party," thus warranting an "enhancement" under United States Sentencing Guidelines, USSG § 2C1.1.(c)(2), including USSG § 2X3.1.

The perpetrators were the "Prosecuting Authority" as defined under Minn. Stat. § 609.902, Subd. 9. The predicate crimes of "State sponsored Domestic Terrorism," espionage and violations of the Third Ku Klux Klan Act of **1871** by "unregistered foreign agent" Nancy E. Brasel, Ku Klux Klan members David T. Schultz, Steven Colloton, and Jonathan Allen Kobes are subject to "enhancements" under Minn. Stat. § 609.714, Subd. 2, of which is "50 percent longer" than that statutory maximum for the underlying offense of USSG § 2J1.2.

The Enforcement Act of **1871**, also known as the Civil Rights Act of 1871, Force Act of 1871, Ku Klux Klan Act, Third Enforcement Act, or "The Ku Klux Klan Act," is the third of a series of increasingly stringent Enforcement

Acts, that are invoked herein to eliminate "extralegal violence" and "protect the civil and political rights" of the current Whistleblower and previously four million freed slaves":

"Let the different classes of our populations feel that the interest and welfare of one is the interest and welfare of all."<sup>39</sup>

II. GROUND II: PETITIONER IS THE ADMINISTRATOR WHO FILED THE CURRENT LITIGATION TO ENFORCE SOPHIA STEWART'S UCC LIEN NO.: 09-72075440; HOWEVER, COVINGTON & BURLING LLP, CLEARY GOTTLIEB STEEN & HAMILTON, JENNER & BLOCK LLP, FREDRIKSON & BYRON P.A. CONSPIRED TO ACT IN THE U.S.A. AS UNREGISTERED ESPIONAGE FOREIGN AGENTS, DEFEATED THE LAWFUL ADMINISTRATION OF THE DOJ TO ADMINISTER AND PROSECUTE FOREIGN AGENTS REGISTRATION ACT of 1938, BRIBED POLITICAL OPERATIVES NANCY E. BRASEL, GLORIA M. NAVARRO, DAVID T. SCHULTZ, RALPH ERICKSON, STEVEN COLLTON, AND JONATHAN ALLEN KOBES, ENGAGED IN RETALIATORY CAMPAIGNS TO STALK THE BLACK WHISTLEBLOWER OVER 9 YEARS, INCLUDING AN IMMEDIATE FAMILY MEMBER, THUS IMPUTING GUILT UNDER THE KU KLUX KLAN ACT OF 1871 AS THE PERPETRATORS COVERED-UP PAYMENTS MADE TO EVADE PROSECUTION FOR THE CRIMINAL OFFENSE OF ESPIONAGE, AND WILLFULLY FAILED TO REGISTER UNDER FARA CITING PROHIBITION UNDER TITLE 22 U.S.C. § 618(e), CROSS-REFERENCING USSG § 2C1.1(c) (2):

Petitioner alleges Subversive Terrorist Lachlan Murdoch conspired to act in the United States as a Foreign Spy, carried out predicate acts of espionage against a Black woman, Sophia Stewart, while the perpetrator laundered Sophia Stewart's federal intangible property for the Terminator and Matrix movie franchise copyrights. The UCC Amended Lien File No.: 11-7276091145 was filed **July 8, 2011**.

**A. SHARED CRIMINAL PURPOSE**

In the case of Sophia Stewart vs. Jonathan Lubell, et al., No.: 2:07-cv-00552-DB-EJF, **Docket 283**, page 4, Honorable Judge Evelyn Furse placed the Respondents Warner Bros. on "constructive notice" that Stewart Stewart is the lawful owner of the work entitled: "The Third Eyes," United States Copyright Registration: TXU 117-610, May 1, 1981, while adjudicating the fact for the Terminator and the Matrix movie franchise to be derivatives.

Murdoch, concealed "a state consent decree" involving violations of the Sherman Antitrust Act, 15 U.S.C. § 1, and covered up commingled bribery payments to Steven Terner Mnuchin involving his "Agreement with Warner Brothers" valued at **\$25,000,000.00**,<sup>40</sup> second "agreement with Warner Bros valued at **\$1,000,000.00**,<sup>41</sup> a joint

ventures between RatPac-Dune Entertainment LLC for commingled funds in the amount of **\$450,000,000.00** for investment into the rights to more than **52** existing and **23** future films by Warner Bros ("WB"),<sup>42</sup> Dune Entertainment, Dune Capital Manager LLC, Dune Capital Management LP, Dune Capital Partners II LP, Dune Entertainment III LLC, Dune Capital LP, Dune Capital International Ltd., Dune Capital Management GP LLC, Dune Capital Partners LLC, Dune Entertainment Holdings, Dune Real Estate Partners LLC, Due Entertainment Partners LLC, Dune Capital Partners LP, Dune Capital Partners IV LLC, Film RatPac Entertainment Holdings LLC, RatPac-Dune Entertainment LLC,<sup>43</sup> WDR Films, AT&T Inc., Receivable Relativity Holdings LLC, Steven T. Mnuchin Inc., OneWest Bank Group, LLC, OneWest Bank N.A., a Time Warner Inc. "Director Fee" of **\$300,470.00** by Attorney General William P.<sup>44</sup> Barr,<sup>44</sup> "exercise of stock options valued at **\$1,320,749.00**, including Barr's "AT&T Inc. Income from corporate acquisition of Time Warner **\$1,732,690**," Dune Entertainment commingled monies valued at **\$325,000,000.00**<sup>45</sup> involving Mnuchin's "Film Financing Agreement with Fox"<sup>46</sup> to fund **16** Feature Films to

"pecuniary gain" Twentieth Century Fox, Fox 2000, Fox Searchlight Pictures, Fox Atomic and Twentieth Century Fox Animation, thus exceeding **\$775,000,000.00**, and then "served" the terrorist rack of spring lamb, burnt cipollini soubise and Carolina gold rice jambalaya, on golden plates, golden glasses, flanked by violins and White House "security detail" on "Black tax-payer dollars" in violation of the Foreign Agents Registration Act of **1938**, citing violations of 5 CFR § 2635.403(a).

#### **CONCLUSION**

Petitioner filed the Tenth Cause of Action for Defamation of Character and Stochastic Terrorism as a result of the Respondents attaching Super Sexual Predator Harvey Weinstein's name from an "official FBI Complaint" to court pleadings in the Tenth District Court before Judge Mary Hannon; in order to obtain a "protection order" resulting in economic reprisal against the Petitioner's immediate family member, and the Whistleblower.

On or about **February 24, 2020**, in the case of the People of the State of New York vs. Harvey Weinstein, No.: 2335/2018, the Super Sexual Predator was convicted of Rape. On or about **March 11, 2020**, Petitioner avers Harvey Weinstein was sentenced to 23 years in prison; of which means the Respondents in the current case committed perjury and document fraud while falsifying a protection order in violation of Minn. Stat. § 626.557, Subd. 6.


