

Further, the appellate division of the superior court lacks jurisdiction to review an order denying a prejudgment anti-SLAPP motion in a limited civil case. (*Citibank, N.A. v. Tabalon* (2012) 209 Cal.App.4th Supp. 16, 19.) The instant action is a limited case. Consequently, we dismiss the appeal.
