

QUESTION(S) PRESENTED

1. Can a defendant be stopped from confronting his accusers and witnesses with other testimony when the 5th Amendment to the U.S. Const. Provides for Due Process?
2. If a defendant's Counsel Compelles defendant to not testify by threat of taking away the right to Counsel is it a violation of the 6th Amendment to the U.S. Const.?
3. For convictions obtained in violation of due process of law under the N.C. Const. Art. I, Sec. 23, 18, and 19 what jurisdiction does the Convicting Court have over the person of the defendant when Counsel for this purpose is not present?
4. Can the right to Counsel be waived when a Counsel's defendant did not waive the right knowingly or with any knowledge of Consent and a valid conviction be obtained in accord with the U.S. Const. Am. 5 and 6 and the N.C. Const. Art. I Sec 19 and 23?
5. Is it cruel and unusual punishment under the 8th Am. to the U.S. Const. to impose a 12 to 17 yr. sentence on a defendant who was denied the right to present evidence in his own defense when the U.S. Const. 5th amendment provides for due process and defendant's Counsel ineffectiveness caused the denial of that right while the 6th amendment to the U.S. Const. Provides for effective Counsel?
6. If Counsel is never present in an effective way does the court have subject matter jurisdiction in a trial setting?
