MOTION TO REQUEST A THIRTY DAY EXTENSION OF TIME TO PREPARE A MOTION
FOR A "WRIT OF CERTIORARI" DURING A MODIFIED LOCK-DOWN FOR SECURITY REASONS

COMES NOW, Shondor Janell Arceneaux, acting pro-se, (Hereinafter to be referred to as the petitioner) seeking an "Extension of Thirty Days Time" to file a "Writ of Certiorari" before this Honorable Court. The petitioner is currently incarcerated within the confines of the Federal Bureau of Prisons at F.C.I. Memphis, which is currently experiencing a term of "Modified Lock-Down," due to security construction upon the Segregated Housing Unit.

Due to the time constraints currently in effect within this institution, it is impossible for the petitioner to safely complete his petition to this

Honorable Court within the next thirty days. Prisoners are regulated to use of the law library with access of only twice per week until completion of the construction currently being done is finished.

Therefore, it is imperative that this court allow a Thirty-Day Extension for time to complete his motion for a "Writ of Certiorari" to the court. The petitioner will do everything within his power to complete the motion in the limited time available, and hope to not have to use this extra time to get his motion completed, but would ask the court to grant him latitude as to the time limits set forth in this matter.

Petitioner also requests that the Clerk of the Court send the petitioner a package form for rules and required format paperwok that is available to make sure that the filing parameters are met properly.

Petitioner would humbly thank this court in advance for its consideration as to the extension of just thirty-days in this matter due to the present lock-down for construction purposes.

The time line limit would expire on October 19th, 2019. The extra thirty days would extend the filing deadline to November 18th, 2019. The petitioner was denied by the Ninth Circuit Court of Appeals on July 19, 2019.
