

1. I am the Petitioner in this case and I declare that I am unable to pay the costs of these proceedings and that I am entitled to the relief requested.
2. I am being held at G. Robert Cotton Correctional Facility. I am currently employed as a unit porter where I earn about \$12.00 monthly. I receive an occasional money order from family.
3. The money I receive is used to support myself in prison, that is, purchase hygiene

items, clothing, self-help materials, telephone calls, food (Petitioner is vegetarian and the prison diet is inadequate). I am also paying state restitution.

4. I do not own any stocks, bonds or property that can be turned to cash. I do not have a bank account or real estate.

5. I do not have any dependents or debts (save state restitution).

6. If the Court denies this motion, I will be precluded from filing the constitutional claims in the petition.
