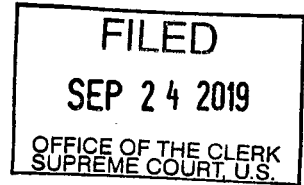

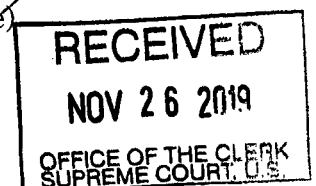

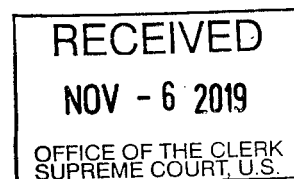


**AFFIDAVIT OR DECLARATION
