

Petitioner Hall has previously been granted leave to proceed *in forma pauperis* in the United States District Court for the Eastern District of Tennessee in *Hall v. Mays*, No. 1:19-cv-341, and continued to proceed *in forma pauperis* on appeal. Further, Petitioner was found to be indigent and permitted to proceed *in forma pauperis* by the Tennessee state courts. Petitioner Hall's counsel was appointed by the United States District Court for the Eastern District of Tennessee pursuant to 21 U.S.C. § 848(q)(4)(B) (2006), presently codified at 18 U.S.C. § 3599.
