

The petitioner asks leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.


Petitioner has previously been granted leave to proceed in forma pauperis in the following court(s):

**AFFIDAVIT OR DECLARATION
