





After carefully considering your appeal, I am affirming EOUSA's action on your request. Regarding your request for records on Aisha Saleem, please note that although EOUSA determined that it might maintain records responsive to your request, EOUSA searched for, but could not find, those records. Subsequent to your appeal, EOUSA conducted additional searches in an attempt to find the missing records, but is still unable to find them. I have determined that EOUSA conducted an adequate, reasonable search for these records. Indeed, EOUSA has not used any exemptions to withhold any information from you; rather, it cannot find the records that might be responsive to your request.

Regarding your request for records on Alex Lewis, it appears that the subject of your request was formerly employed by EOUSA. The National Personnel Records Center (NPRC), which is part of the National Archives and Records Administration (NARA), bears primary responsibility for maintaining records of former federal government employees. I suggest that you submit a request to the NPRC for the records you seek at the following address:


