APPLICATION FOR EXTENSION OF TIME TO FILE PETITION FOR WRIT OF CERTIORARI.

NOTICE IS HEREBY GIVEN that Petitioner Octavio Diaz applies to this Honorable Justice for an extension of time to file his Petition for Writ of Certiorari.

Jurisdiction is based on 28 U.S.C., §1257(a).

Petitioner is seeking relief by way of Certiorari of the Judgment of the California Court of Appeal, Fourth Appellate District, Division Two, dated May 31, 2019, in the case of *Diaz v. County of San Bernardino*, California Court of Appeal No. 4th Civ. E068838. A copy of the Unpublished Opinion is attached as Exhibit "A" to the Declaration of Octavio Diaz. A Petition For Review was denied by the California Supreme Court on August 21, 2019.

Petitioner is requesting an extension of time to file for Certiorari in part because he is of age, and still has compile the issues needed to be discussed in the Petition.

Petitioner applies on the following grounds that:

1. Petitioner is likely to succeed in his Certiorari Petition in that the Superior Court erroneously granted summary judgment based on "probable cause" when he was defending himself with a gun against a White, multiple-strike convicted felon, and trespassing Hell's Angels member, even though the case of *Manuel v. City of Joliet*, 137 S. Ct. 911, 919-920, and fn. 8 (2017), now allows a review of the lack of probable cause may be reviewed, where he was later found **NOT GUILTY**.
2. Petitioner is requesting up to 60 days to file for Certiorari in that he wants more time to gather copies of the rulings for his Appendix to his Petition. Because the California Court of Appeal disregarded the precedents of this Court, and is in conflict with the Second, Third, Fifth, Sixth, Seventh and

Tenth Circuits, and the Oklahoma Civil Court of Appeals, Petitioner would like to discuss these issues in his Petition herein.

Petitioner requests that he be given up to 60 days to file his Certiorari Petition, or in the alternative, that this Application be granted up to 30 days to properly prepare his Petition.

This Application would be based on the Declaration of Octavio Diaz, the record of proceedings before the Superior Court and the California Court of Appeal, and on any oral or documentary evidence that may be presented at the consideration of this Application.


I, Octavio Diaz, declare that:
