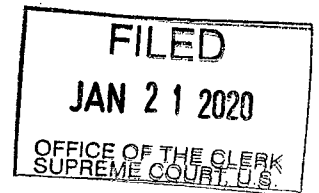

Under the 13th Amendment to the United States Constitution reads as follow:


Neither Slavery nor involuntary servitude, except as a punishment for a crime whereof the party shall have been convicted shall exist.

Now if the defendant has not committed a crime and the Court of Appeals division III has concured, why is the defendant being punished with Slavery and mandatory servitude?


What makes this case exeptional?
