Petitioner Donnie Cleveland Lance, by and through undersigned counsel, requests leave to file the attached Petition for Writ of Certiorari to the Georgia Supreme Court and Motion for Stay of Execution without prepayment of fees and costs, and to proceed in forma pauperis, pursuant to Rule 39 of the Rules of this Court.

In support thereof, Petitioner shows this Court the following:

- 1) Petitioner is currently confined at the Georgia Diagnostic and

Classification Prison in Jackson, Georgia, and has been so confined under

sentence of death since 1999. Petitioner was permitted to proceed as an indigent, without payment of costs and fees, in the Butts County Superior Court and in the Georgia Supreme Court. *See* Attachment A.

- 2) Undersigned counsel was appointed to represent Petitioner in pursuing habeas corpus relief in the federal courts pursuant to the Criminal Justice Act. *See* Attachment B.
- 3) Petitioner remains indigent and wishes to seek a writ of certiorari from this Court to the Georgia Supreme Court, which affirmed the lower court's denial of his petition for writ of habeas corpus.

Wherefore, Petitioner respectfully requests that this Court grant his motion and allow Petitioner to proceed in forma pauperis in petitioning for a writ of certiorari without prepayment of costs or fees.


