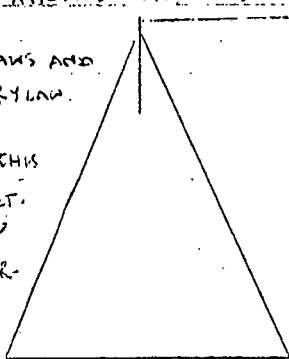

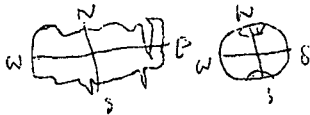

AND THE IDENTITY PRODUCED THE ILLEGAL ALIENS. SO THE CONGRESS OF THE FEDERAL U.S.A. PUT THE ILLEGAL TO LEGAL FRAME WORK AND NAMED IT THE LOCALIZATION AND GIVING THE DICE OR PRO-
 -FORMA AND CALLED IT THE IMMIGRATION REFORM LAW (OF) 1986 OR ONLY THE REFORM (EMMIGRATION); INVOLVING THE SPECIM, AND AMNESTY, HIRE/PAY, REFOR AND CONTINUED. EMPLOY-EMPLOYER - THE EMPLOYMENT AND THE EARNING (THE US IS MUST BEEN REFORM; THE COMPLEIS) IS THE INPUT UNIT FAMILY OUTPUT THE GENERATIONS TO BUILD, LET NOT THE U.S.A. TO HAVE THE VIOLENT ALIENS, AND RESERVED THE EMPLOYER SANCTIONS (FORM-9 VERIFICATION) AND THE EMPA'86; REQUIRED TO ENFORCE THE LAW AND ITS VERY SIMPLE WAYS, THE FACT IS THAT THE ABOVE INFORMATION GET REVERSED DUE TO THE REPAIRS PROCEEDING OUT REINJURED OVER AND OVER AGAIN AND CONTINUOUSLY ALLOWED THE ILLEGAL WORKS FOR THE MANY MAKING THE SHADE OF THE U.S. COMMUNITIES DEFORM (REINJURED); THE REPAIRS REQUIRED THE EMERGENCY BASIS TO CONTROL THE ILLEGAL OR OVERSTAYED ALIENS (THEIR ALIENAGE). [1] VICTIM AND ACCIDENTS: NONE COULD TELL EXACTLY WHEN THE ACCIDENT(S) COULD GOING TO TAKE PLACES. IT OCCURRED BETWEEN THE SUBJECTIVE ELEMENTS AND/OR BETWEEN THE OBJECTIVE ELEMENTS.

[2] REPAIRS: HOW MANY TIMES GIVEN THE REPAIRS? THE RECORDS IS THE ONLY WAY COUNTS THE DIARIES/JOURNALS. THE TIMELINE CREATING THE BOOKS MUST KEEPING FROM OUR BIRTH TILL DEATH.

[3] THE US 3-BRANCHES OF THE GOVERNMENTS AND IT CONNECTIONS: (A) WE WATCH EVERYDAY THE INTERIOR CONNECTIONS, (B) AND THE DISPLAY OF THE EXTERIOR CONNECTIONS; HOW TO KEEP THE CONNECTIONS CONTINUOUSLY? FOR EXAMPLE THE SUBJECTIVE ELEMENTS AND THE OBJECTIVE ELEMENTS USED TO PRODUCE THE EVALUATING THE COMPREHENSIVE RESULTS GIVING THE CUMULATIVE TOTAL.

(A) THE LEGISLATIVE BRANCH (REPRESENTATIVE - U.S. SENATE AND HOUSE OF REPRESENTATIVE SOME HONORABLE BODIES LIKE THE SPORTS AND GAMES COPEA THE CONSTITUTION AND DESIGN THE FORMS ACCORDANCE WITH THE LAWS (B) THE EXECUTIVE BRANCH (THE U.S. PRESIDENT SIGN THE BILL INTO THE LAW OR ADMINISTERS THE CABINET AND THE VICE PRESIDENTS) (C) AND THE JUDICIAL BRANCHES OF THE GOVERNMENT EVALUATING THE LAWS JUST PREPARED (BEFORE DURING AND AFTER THE LAW MAKING THROUGH LET THE MOTHER BOOK OF THE U.S. CONSTITUTE FOCUSING THE PATHWAYS/AVENUES/ROUTES HOW THE BILL BECOME LAWS. LIKE WE INVEST THE BUILT HANDS EVERYDAY INTO THE JOB DUTIES WE PERFORM. LIKE DRIVING WORK EXPANDED THE FORMS OF THE BODY FUNCTIONS, FOR EXAMPLE THE ASTRONAUT(S) INSIDE THE SPACE SHUTTLE GOING TO ANOTHER PLANET(S), QUESTIONS (1) WHAT BODY PARTS HE CARRYING WITH HIM AND WHAT BODY PARTS HE LEFT (AND OR FORGOT TO TAKE WITH HIM)? ANSWER IS NO. (2) ALL THE BODY PARTS IS ASSEMBLED OR FASTENED TOGETHER TO COMPLETE THE HUMAN BEING UNDER THE GODS GIVEN MAINTENANCE, (3) YET WHY THERE IS AN ACCIDENT(S) AND THE RESPONSIBILITIES AND THE LIABILITIES CONCERNS? ANSWER IS NO. (4) SIMPLY THE REPAIRING GARAGES (THE SUBJECTIVE ELEMENTS AND THE OBJECTIVE ELEMENTS GIVING THE TOTAL (GROWTHS)). THE GROWTHS ARE SPECIFIC TOO, A. THE CONDITIONS; B. AND THE AFFAIRS; THESE PHENOMENON BEARING THE CIRCUITS.
