

THE COURT FINDS:

The matter is before the Court on Defendant's successive motion for relief from judgment pursuant to MCR 6.500, et seq. For the following reasons, the Court declines to consider Defendant's motion:

A defendant cannot file a successive motion for relief from judgment that is not based on one of the two exceptions in MCR 6.502(G)(2). People v Swain, 288 Mich App 609, 631 (2010). Here, after reviewing the pleading, the Court finds that Defendant has failed to show that his claim for relief is based on either (1) a retroactive change in the law, or (2) evidence that was not discovered before his first motion for relief from judgment was denied. Because Defendant has previously filed a motion for relief from judgment, and he did not establish that the claim in the instant motion fell within one of the exceptions in MCR 6.502(G)(2), this Court will not consider the claim. MCR 6.502(G)(1). Swain, 288 Mich App at 631.
