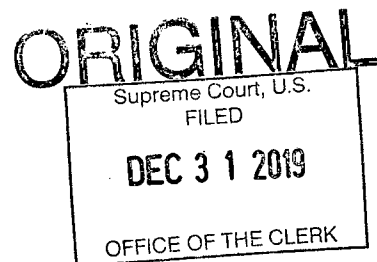

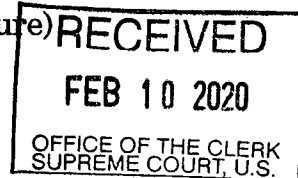

No action will be taken on the document until these deficiencies are corrected.

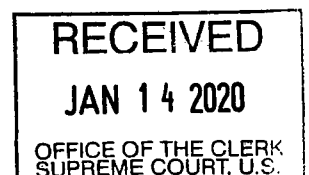


