MOTION FOR DIRECTING THE CLERK OF SUPREME COURT
TO FILE A PETITION FOR THE REHEARING OUT-OF-TIME

Hereby, petitioner "Jerome Shaw" files his motion seeking this Office of the Clerk to file his Petition for the Rehearing of this U.S Supreme Court's Order denying a "petition for a Writ of Certiorari" out-of-time as required and advised by its letter dated on July 1, 2020.

Petitioner admitted that he failed to timely file it within 25 days as required by Rule 44 and Rule 39 as he indicated on his letter addressed to the Clerk of this Court on June 11, 2020 and it received on June 24, 2020. However, instead of sending this office a letter to explain that petitioner faced serious difficulty and extraordinary circumstances caused by Covid-19 pandemic lockdown at USP Canaan where all inmates remained in their own cells, per this office's letter dated on July 1, 2020, petitioner Shaw should resubmit it by directing the Clerk to file it in a "Motion", not "Letter" under "Out-of-Time" process.

Herewith, Petitioner attached a copy of this facility USP Canaan's Memorandum To The Inmate Population to prove his facing serious difficulty and extraordinary circumstances that caused him to file his petition for

the rehearing of this Court's Order denying his petition for a Writ of Certiorari. Failing to file his petition for the rehearing timely within 25 days as required by Rule 44 and Rule 39 is NOT petitioner's fault and ignoring such Rules, but Covid-19 to prevent from its transmission outbreak in this facility where the BOP took it seriously to avoid such pandemic outbreak. A person to be blamed is WU-HAN Chinese virus, not petitioner, not the BOP, and not this Court either.

At this point, petitioner wishes this Office of the Clerk to refile this petition for the rehearing due to serious difficulty and extraordinary circumstances that this BOP facility closed and petitioner could not access to the law library and legal materials as well this old typewriter to prepare his petition for being filed timely within 25 days as required by Rule 44 and Rule 39 in this Court.

CONCLUSION

WHEREFORE, based on the above mentioned factual pleading, Shaw "Petitioner" hereby prays that this Office of the Clerk refiling his petition for the rehearing due to the serious difficulty and extraordinary circumstances as he explained and attached with a evidence (The BOP's Memorandum To The Inmate Population Dated on March 19,2020), for the Clerk's reconsideration.

SUBJECT: COVID-19 Update

This memorandum serves to update the Inmate Population in relation to COVID-19 Virus and USP Canaan's operations. We are moving toward a more normal operating schedule next week as we take into account the realities of the COVID-19 Virus.

Due to social restrictions on visitation, telephone minutes have increase to 510 minutes monthly until visitation restrictions are lifted. We do encourage all inmates to practice proper hand washing techniques, good personal hygiene and maintain good cell sanitation.

Starting Monday, March 23, 2020, the institution will operate on the following modified schedule until further notice: A reduced number of Food Service, Laundry and Commissary workers will be utilized to work inside the institution. All inmates will receive each meal in their assigned cell. Monday through Friday, inmates on the upper housing unit tier will be released from 9:00 a.m. to 11:00 a.m. daily to use the showers, telephones and computers. Inmates on the lower housing unit tiers will be permitted to exit their cells from 1:00 p.m. to 3:00 p.m. daily.

Commissary sales have been set at \$90 a week until further notice. Below is the Commissary shopping rotation.
