



Comes Now, Tzedkiyah EL Bey, in the above style case, hereby files Notice to Proceed In Forma Pauperis in this court, and this Affiant suffered damages Without Due Process of Law, and is an indigent person whom presently is not employed, do not have a reliable source of wages, do not own any gold, silver, and cannot afford to pay the court cost. Therefore, this writ request to Proceed In Forma Pauperis should be granted in accord with substantive right to due process of law per the 5<sup>th</sup> Amendment to the National Constitution 1791, and, in accord with Steffler v. United States, 319 U.S. 38 (1943) "A poor person entitled to prosecute an appeal from the District Court to the Circuit Court of Appeals is authorized by the *in forma pauperis* statute to apply to the District Court for leave to appeal *in forma pauperis*, and it is the duty of the District Court to entertain the application; and, not being repugnant to Article 1 Section 10 of the

National Constitution (1791), Specifically, speaking, Article 1, *Section X*. "All debts shall be payable in gold or silver coin" *Amendment V* "No Person shall be deprived of due process of law".

FURTHERMORE,

- 1) No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Re-prisal; coin Money; emit Bills of Credit; **make any Thing but gold and silver Coin a Tender in Payment of Debts**; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility,
- 2) There has not been any lawful money in circulation whereby debts can be satisfied since 1933 as President Franklyn D Roosevelt suspended the gold standard per House Joint Resolution 192.

I Affirm, for the Record, that I do not have, or possess, any gold or silver coin, as prescribed by United States Constitutional Law, which is the lawful money to pay the restricting demands, conditionally commanded by Employees and Contractors of the Court. The said restrictions (unconstitutional) are arbitrarily (hindering Due Process) and imposed for processing these Documents, as stipulated in the United States Constitution noted above.


