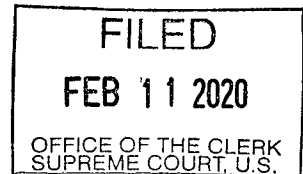

I am currently divorced and have three children from my previous marriage. All my children are adults and they now help me with basic needs and money to buy food and hygiene items from commissary.
