

QUESTION(S) PRESENTED

- 1) WHETHER THE DISTRICT COURT IS DENYING AN INDIGENT CIVIL DETAINEE (PRE-TRIAL DETAINEE) FOR SEVEN YEARS (JUNE 26, 2012) FROM ACCESSING THE COURT WHEN PLAINTIFF EARNS NO MONIES AND IS WELL BELOW THE FEDERAL POVERTY LEVEL.
- 2) WHETHER THE DISTRICT COURT AND THE COURT OF APPEALS ASSESSING \$1,000.00 SETTLEMENT MONEY AS INCOME AND DID NOT TAKE INTO CONSIDERATION THE LITIGATION EXPENSES OF \$1,300.00 ONLY TAKING INTO CONSIDERATION OF FABRICATED ILLINOIS DEPARTMENT OF HUMAN SERVICES TREATMENT AND DETENTION FACILITY TRUST FUND REPORTS.
- 3) WHETHER THE PLAINTIFF EARNS ANY MONEY AT THE "IDHS/TDF" FACILITY ONLY LIFE REWARD POINTS ONLY TO BE USED AT THE FACILITY STORE TO PURCHASE HYGIENE, LEGAL SUPPLIES, CLOTHES AND FOOD AND THE US DISTRICT COURT WOULD NOT ORDER THE "IDHS/TDF" TO CONVERT THESE POINTS TO MONEY FOR THE FILING FEES.
- 4) WHETHER THIS INDIGENT PLAINTIFF CANNOT EARN MONIES AND IS BEING HELD UNCONSTITUTIONALLY IN A ILLINOIS "SECONDARY PRISON SYSTEM" AND CANNOT ACCESS THE COURT BECAUSE OF HIS INDIGENCY.
- 5) Whether Plaintiff who earns "No Monies" has abused the District's partial filing fee procedure.
- 6) Whether Plaintiff is being treated as a prisoner under the Prison Litigation Reform Act. 28 USC 1915(g) and applying the District Court in making their own rules 28 USC 1915(g)
- 7) Whether Plaintiff can access the court on a Motion to Rescind Order Baund vs Smith 430 U.S. 817 (App B)


REASONS FOR GRANTING THE PETITION
