## **PETITION FOR REHEARING**

Pursuant to Sup. Ct. R. 44.2, petitioner, Angello Osborne (“petitioner”), respectfully petitions this Court for an order (1) granting a rehearing, and (2) vacating the Court’s May 18, 2020 order denying certiorari in this matter. As grounds for this petition for rehearing, petitioner provides the following information:

1. On January 25, 2011 Petitioner was arrested and held without bail for more than eight months after being falsely accused of sexually assaulting his five year old daughter. On February 15, 2011, he was indicted on sixteen counts of sexual assault related crimes. His indictment was Ultimately, the state declined to prosecute. Instead, the state offered to indefinitely postpone the criminal case by placing the charges on the “stet” docket. Petitioner, desperate to be released from his lengthy incarceration, accepted the state’s offer and was immediately released from custody.

2. Petitioner filed suit challenging the constitutionality of his arrest and incarceration. Petitioner asserted that the defendant, Corporal Peter Georgiades (Georgiades), the police officer assigned to investigate the sexual assault allegations, fabricated evidence by coaching Petitioner’s daughter to inculpate him. Petitioner also asserted that Georgiades knowingly omitted information from his probable cause application that would exonerate Petitioner.

3. Georgiades moved for summary judgment claiming qualified immunity. The district court denied the motion, holding that a jury could conclude that Georgiades exerted undue pressure on the that resulted in the fabrication of evidence. The court also found that a jury could conclude that Georgiades deliberately, or with reckless disregard, omitted material facts that would have negated probable cause for Petitioner's arrest.

4. Georgiades appealed his denial of summary judgment to the Fourth Circuit Court of Appeals. The Fourth Circuit affirmed the district court decision. Thereafter, Georgiades filed a second motion for summary judgment based upon his assertion that the entry of the criminal case on the "stet" docket was not a final determination that resulted in Petitioner's favor, thereby precluding Petitioner's claim. The district court granted the second motion and dismissed Petitioner's case.


5. Petitioner suffered and continues to suffer damages to his reputation as a result of Georgiades's fabricated evidence against Petitioner. Not only did Georgiades's fabrications and omissions result in Petitioner's lengthy and unjust incarceration, but they also contributed to a derogatory WMAR-TV newscast dated February 3, 2011 that, even today, can be seen on the internet at [Youtube.com/watch?v=P4KoNpqE0jk](https://www.youtube.com/watch?v=P4KoNpqE0jk).

6. Georgiades should not be absolved of his intentional and / or reckless disregard for Petitioner's rights simply because Petitioner accepted

the state's offer to place his criminal case on the "stet" docket. Petitioner accepted the state's offer under duress and in desperation to be released from prison where he had been unjustly incarcerated.
