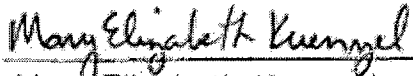

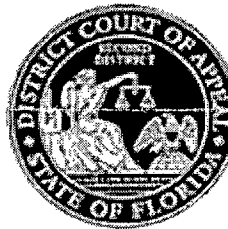

From the moment he came into the cell (Z man), I was at peace, shared my commissary and shoot the breeze.

Then for no reason, buddy just started tripping. Not just on me, but on others too.

A few nights before this happened, I'm laying in the bed, and all of a sudden, he jumps up, hitting his fists together and acting like he was about to pop off on me. (Justin Dieter who has since (before the fight) witnessed this as he was on a boat outside our cell).

Because I was doing DC time for the fight, I was not brought to court. So I was not able to request Mrs. Pardo to try and get the video of that night.

And the earlier video of that day, which'll show him walking up on me in front of the gate, and while standing at the mirror.

It'll show I was sitting on my bunk after dinner, and he purposely kicked me while in the cell, purposely kicked me again going out, and then did it again.

I do not know how to contact Mrs. Pardo and ask that you forward a copy of this so she can get that video footage for my defense.

Please so I can have a fair shot at trial.

Safon has been after me and just have had me thrown into one seg after another.

I swear I do use drugs. Only for pain until I got meds from Dr.

I went to St Anthony's emergency room and begged for pain meds. (Mrs. Pardo please get these records too). I had an appt. on March 28. I had already been to X-ray twice. Once with medicaid at Johnny B. Ruth Clark. Then I signed up for Wellcare with my medicare.

I went to Suncoast Mental Health. And I even called Well Care for a psych doctor.

I have no one to help me. There is no help in prison.

The psych doctor Mrs. Pardo spoke of never did come see me. I am a diagnosed

paranoid schizophrenic. I do not trust police and DID NOT CONSENT.

Gosh, why didn't APD Mierzkowski get the video.

The only plea I'd accept is some sort of mental health residential program where I can get some professional health.

I don't want to be God. It doesn't make sense to me, yet I know I am.

It's like He's trying to make contact with the mental health.

I know so much and swear have not one negative bone in my body.

You guys have got to work with me. Because believe me, the judicial is bringing about the end.

Let me spend some time with the pros and I'll give them the dark side of what I've seen, heard and did and want to do.

Bring about the Kingdom of Christ Jesus.

But then there'd be no need for judges, lawyers or prosecutors, as there'd be no crime. See how entangled things is.

Let it be on record, I have requested that video footage from the date I was moved into 5F7 7-13 or 14 to the day of the fight 7-22 be obtained by counsel on my behalf because it will show the threatening, hostile and provoking actions of Mr. Chapman which lead up to the altercation that he provoked and started.

And Mrs. Pardo, when you depose him and ask him about the events, you'll see. And with the other peoples in the cell.

I would have gladly moved, but the jail don't move people unless you get beat, or you beat someone, or you fake psych and go to built-made cell.

This is also selective prosecution, as there have been 3 or 4 fights daily in this jail. This is only my third. It's just the nature of life behind the bars and why I did not plan some depraved crime.
