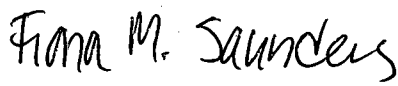
12. Provide any other information that will help explain why you cannot pay the costs of this case.

I have never previously requested leave to proceed *in forma pauperis* in any other court of Connecticut. This is the first time I am requesting such a relief. I have been making a lot of photocopies of documents to mail to all parties when I filed any documents in the Connecticut court system. The cost of certified mail is overwhelming when my case has so many plaintiff's and defendant's attorneys to mail to and to make copies and to buy envelopes. I have spent lots of money and find myself not able to finish paying my bills. I am two months behind with my car payment and have been behind with other bills. My ex-husband has not paid me the alimony ordered by the divorce decree agreement and he is close to \$8,000 in arrears and I can't afford at this point to take him back to court. Therefore, I am struggling as I have more bills than income.
