ORDER

Adrian Weatherspoon filed a Tenn. R. App. P. 11 application for permission to appeal on November 4, 2019 from an order of the Court of Appeals filed on August 28, 2019, dismissing his appeal as untimely. An application for permission to appeal must be filed within sixty (60) days of the filing of the judgment of the intermediate appellate court or, if a timely petition for rehearing was filed, within sixty (60) days of the entry of the order on the petition for rehearing. *See* Tenn. R. App. P. 11(b). Accordingly, the application to this Court was due on or before October 28, 2019. The sixty-day period for filing an application for permission to appeal is jurisdictional in civil cases and cannot be extended. *See* Tenn. R. App. P. 2 & 21(b) and *State v. Sims*, 626 S.W.2d 3 (Tenn. 1981).

It is, therefore, ordered that the application for permission to appeal be dismissed. Costs are taxed to Adrian Weatherspoon, for which execution may issue if necessary.

ORDER OF DISMISSAL AND JUDGMENT

THIS CAUSE CAME ON FOR TRIAL BEFORE THE COURT, sitting without a jury, on January 8, 2019, with Defendants Robert Seeman, Autumn Sterling, and Scott Palmer being voluntarily dismissed immediately preceding the trial, and upon consideration of the evidence produced, the testimony of Plaintiff, testimony of Defendant Fatemah Baghaipour, Exhibits 1 through 4, attached and incorporated herein by reference, arguments of counsel for Defendants Seeman, Sterling, Palmer, and Vincent Brooks, the Court finds that claims against governmental entities and their employees must be brought in strict compliance with the Governmental Tort Liability Act (GTLA); that claims were not brought in compliance with the GTLA; that there is insufficient proof to support any claim against any of the Defendants in this matter; from which the Court finds that Plaintiff did not carry his burden of proof in this case and that judgment should therefore be granted in favor of all Defendants.
