IN FORMA PAUPERIS

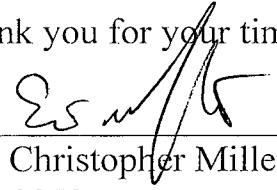

Attached is an Affidavit or Declaration In Support of this Motion.

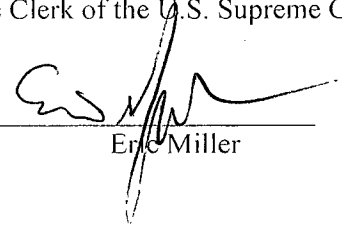
Wherefore, Petitioner prays the Court grant him leave to proceed *in forma pauperis*.

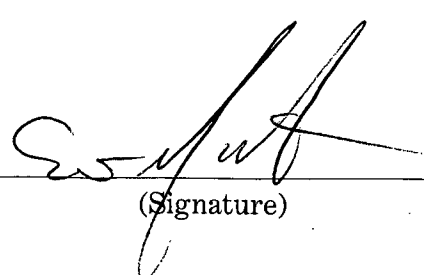
